ORDER:

The Project on "Land Use Planning and Management" under Indo German Development Cooperation between Duetsche Gesellschaft fur Internationale Zusammeinarbeit (GIZ) and Planning Development & Special Initiatives Department has been approved as per the Government Order cited. The objectives of the project is to strengthen the overall culture of a democratic and integrative spatial and land use planning at all levels within the State by enhancing the capacities of State Planning institutions in applying standard land use planning and management instruments. The Note of Cooperation (NoC) agreement between Planning Development & Special Initiatives Department and Duetshe Gesellschaft für Internationale Zusammeinerbeit (GIZ) signed on 27.09.2017 before the Hon'ble Deputy Chief Minister.

2. After careful consideration, Government constitute a State Level Steering Committee to facilitate, evaluate, monitor and steer implementation of the Integrated

- ii. To facilitate, evaluate and monitor the implementation of the DoLR-GIZ cooperation project on 'Land Use Planning and Management' in the state of Tamil Nadu.
- iii. Review of baseline situation analysis applicable at the state level.
- iv. Understand the land use planning system and case examples from other states in India, Germany and other relevant countries as presented by experts from Germany/ GIZ and explore their relevance to Tamil Nadu.
- v. Review draft policy preparation on land use planning and management for the
