ORDER:

The Hon'ble Minister for Finance and Human Resources Management made announcements pertaining to Chennai Metro Rail Limited (CMRL) on 07-05-2022 while moving the Demand No. 36, Planning, Development and Special Initiatives Department in the Legislature, for undertaking Detailed Feasibility Studies for extension of Phase-II of Chennai Metro Rail Project as indicated below:

- 1) Extension of Corridor-4 from Poonamallee Bypass upto Sriperumbudur
- 2) Extension of Corridor-5 from Thirumangalam upto Avadi, via Mugappair and Ambattur
- 3) Extension of Corridor-3 from Siruseri to Kelambakkam
- 4) Extension of Corridor-3 further from Kelambakkam to Kilambakkam Bus Terminal via Mambakkam and Vandalur

2. The Chief General Manager (P & BD), Chennai Metro Rail Limited (CMRL) in the letter read above, has sent detailed proposal for undertaking the feasibility studies for extension of Chennai Metro Rail Project and indicated that the cost of studies is to be met out by Chennai Metro Rail Limited. The duration of each study is 4 months and the total estimated cost of consultancy is Rs. 145.00 lakhs.

3. The Government after careful consideration of the proposal, accords administrative approval for undertaking the Detailed Feasibility Studies by Chennai Metro Rail Limited (CMRL) in respect of following extensions of Phase-II of Chennai Metro Rail Project:

- 1) Extension of Corridor-4 from Poonamallee Bypass upto Sriperumbudur
- 2) Extension of Corridor-5 from Thirumangalam upto Avadi, via Mugappair and Ambattur
- 3) Extension of Corridor-3 from Siruseri to Kelambakkam
- 4) Extension of Corridor-3 further from Kelambakkam to Kilambakkam Bus Terminal via Mambakkam and Vandalur

The duration of each study will be four months and the cost of the studies will be met by CMRL.

4. The Chennai Metro Rail Limited is requested to send progress of Feasibility studies mentioned in para 3 above to this department on monthly basis.

5. This order issues with the concurrence of Finance Department vide U.O.No.2057/FS/P/2022, dated: 26.05.2022.
