ORDER:

In the letter read above, the Principal Secretary/Commissioner, Department of Economics and Statistics has stated that the productivity and production of agricultural crops in Tamil Nadu is estimated through crop cutting experiments under the crop estimation surveys. The Department of Economics and Statistics is designated as State Agriculture Statistics Authority (SASA) for planning and organizing the survey. The primary work of crop cutting experiments is vested with Agriculture and Horticulture Departments under the technical guidance of the Department of Economics and Statistics. Refresher training is imparted to field staff and supervising staff in districts in the beginning of every Fasli year. Further, the crop cutting experiments play a vital role in estimation of yield and production, a refresher training has become imperative for field staff to conduct the crop cutting experiment.

2. The Principal Secretary/Commissioner, Department of Economics and Statistics has requested the Government to provide an addl. amount of Rs.13,95,000 for conduct of Crop Cutting Experiment Refresher Training in 31 districts(except Chennai) at Rs.45,000/- each for the year 2015-2016.

3. The Government after careful consideration accept the proposal of the Principal Secretary/Commissioner, Department of Economics and Statistics and accordingly sanction a sum of Rs.13,95,000/- (Rupees Thirteen lakhs ninety five thousand only) for conducting Crop Cutting Experiment Refresher Training in 31 districts (except Chennai) at Rs.45,000/- each for the year 2015-2016.

4. The expenditure shall be debited under the following Head of Account:

"3454- Census Surveys and Statistics -02 Surveys and Statistics 110. Gazette and Statistical Memoirs -I. Non-plan - AE. Integrated Scheme for Development of Statistics". 72.Training (DPC. 3454-02-110-AE-7202).

5. Necessary additional funds of Rs.13,04,000/- will be provided in RE/FMA 2015-2016. Pending provision of such funds in Revised Estimate/Final Modified Appropriation 2015-2016, the Principal Secretary/Commissioner, Department of Economics and Statistics is authorized to incur the expenditure. This expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimates 2015-2016. The Principal Secretary/Commissioner, Department of Economics and Statistics shall include the amount sanctioned in para-3 above while sending budget proposal for Revised Estimate/Final Modified Appropriation 2015-2016 to Government without fail. The Principal Secretary/Commissioner, Department of Economics and Statistics is also directed to send necessary explanatory notes to Finance (Public) Department for inclusion of this expenditure in the Supplementary Estimates 2015-2016.
