ORDER:

In the reference read above, the Managing Director Chennai Metro Rail Limited has requested to fillup the posts of 1 District Revenue Officer, 2 Deputy Collectors and 2 Tahsildars in addition to the existing team to Chennai Metro Rail Limited on deputation basis exclusively for looking after the Land Acquisition process and Private Negotiation in respect of Phase –II of Chennai Metro Rail Project. The Managing Director Chennai Metro Rail Limited has also pointed out that the posts of 1 District Revenue Officer, 2 Deputy Collectors and 2 Tahsildars have already been created in Chennai Metro Rail Limited on temporary basis, within the powers of the Managing Director and that the above posts will be operational from the date of filling up of the posts through deputation of Revenue Department officials from the State Government.

2. The Government, after careful consideration, have decided to fillup the posts of 1 District Revenue Officer, 2 Deputy Collectors and 2 Tahsildars from suitable personnel from Revenue department on deputation basis exclusively for looking after

the Land Acquisition process and Private Negotiation in respect of Phase II of Chennai Metro Rail Project in addition to 1 District Revenue Officer and 2 Deputy Collectors working in Chennai Metro Rail Limited on deputation basis and looking after the land acquisition issues relating to Phase I and Phase I Extension of Chennai Metro Rail Project.

3. The Public (Special-A) Department and Revenue Department shall issue necessary orders posting 1 District Revenue Officer, 2 Deputy Collectors and 2 Tahsildars to Chennai Metro Rail Limited on deputation basis for an initial period of one year from the date of filling up of the post.

4. This order issues with the concurrence of Revenue Department vide its U.O.No.7077/LA-II/2018, dated 26.03.2018 and Finance Department vide its U.O. No.53163/Finance (Hg&UD)/2018, dated 27.11.2018.
