ORDER:

The Director (FAC), Evaluation and Applied Research Department in the letter read above has requested to sanction a sum of Rs.60,80,981/- towards payment for Evaluation Studies approved by the State Evaluation Committee 2015-2016 to be undertaken through outsourcing.
