In the reference first read above, the Hon'ble Chief Minister has announced that this Government proposes to establish a Data Analytics Unit as collaboration between Department of Economics and Statistics and the Tamil Nadu e-Governance Agency to analyze, in real time, the large volume of data available with the Government to enable improved policy making for better service delivery. Tamil Nadu will be the first state to establish such unit.

2. In the reference second read above, the Principal Secretary/ Commissioner, Department of Economics and Statistics has proposed to set up the Steering Committee for approving the proposals of the Cell/ Data Analytics Unit and monitor the progress of the proposals.

The Cell/ Data Analytics Unit located at Department of Economics and Statistics will be under the overall supervision and guidance of the Steering Committee and also approve the proposals of the Unit and monitor the progress of the proposals. This committee will meet once in three months.
