Land Acquisition – Chennai and Tiruvallur districts – An extent of 17.77.11 hectares – Acquisition in favour of Chennai Metro Rail Limited for implementation of Chennai Metro Rail Project under the provisions of Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997 (Tamil Nadu Act 10 of 1999) – Sanction of Special Staff for land acquisition - Orders – Issued.

ORDER:

Based on the request from the Managing Director, Chennai Metro Rail Limited, in his reference second read above, the District Collectors of Chennai and Tiruvallur in their references third and fourth read above have sent proposals for according administrative sanction for acquisition / alienation of land approximately 17.77.11 hectares to the Commissioner of Land Administration. The Additional Chief Secretary / Commissioner of Land Administration, in her references fifth and sixth read above, has recommended the proposals of the District Collectors for acquisition under Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997. She has also recommended for sanction of 21 posts of special staff in Chennai and Tiruvallur districts for attending land acquisition works, after adjusting the 5 posts being continued in respect of Chennai unit.

2. The Government Order seventh read above, administrative sanction has been accorded for acquisition of 6.48.56 ha of patta lands as identified by Chennai Metro Rail

Limited and District Collectors, Chennai and Tiruvallur under the provisions of Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997 (Tamil Nadu Act 10 of 1999). The Government also accorded for alienation of 11.28.55 ha of Government lands, for implementation of Chennai Metro Rail Project.

- 3. The Government now sanction 21 (Twenty one) posts of Special Staff, consisting of one Special Tahsildar and 12 special staff each to Chennai and Triuvallur districts, after adjusting the 5 posts being continued in respect of Chennai District as per G.O.Rt.No.120, Planning, Development and Special Initiatives (SI) Department, dated 12.5.2015, as mentioned in Annexure to this order, to look after the Land Acquisition relating to Chennai Metro Rail Project, for a period of one year from the date of employment or till the completion of the scheme work, whichever is earlier.
- 4. The entire cost of land acquisition staff will be met by Chennai Metro Rail Limited. The expenditure towards Special Land Acquisition staff recovered from the Chennai Metro Rail Limited shall be credited to the following receipt head of account.
- "0070. Other Administrative Services 60 Other Services -800 Other Receipts CH Reimbursement of Establishment charges towards Land Acquisition work done for Private / Public Sector undertakings. (DPC 0070 60 800 CH 0008)"
- 5. The expenditure towards the cost of Special Land Acquisition staff shall be debited to the following head of account:
- "2053.00 District Administration 094 Other Establishment I Non Plan –EH Establishment for Acquisition of Lands for Chennai Metro Rail Limited 01 Salaries. (DPC 2053 00 094 EH 0106)"
- 6. After completion of the project work, the entire cost of the establishment charges should be transferred to respective expenditure service head of account in the detailed head "Deduct Recoveries" by presenting necessary adjustment bills to the Pay and Accounts Office / Treasury concerned.
- 7. The Additional Chief Secretary / Commissioner of Land Administration is requested to watch the recovery of cost and arrange to credit it into Government account.
- 8. The District Collectors of Chennai and Tiruvallur districts are requested to fill up the posts sanctioned in para 3 above.
