The State Planning Commission has recommended the proposal of Implementation of Dynamic Data Visualization and Interactive System (Video Conferencing) TANII Scheme at a total cost of Rs.47.50 lakhs under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2016-2017, 2017-2018 and 2018-2019.

2) The Standing Finance Committee has approved the scheme of Implementation of Dynamic Data Visualization and Interactive System (Video Conferencing) TANII Scheme as recommended by the State Planning Commission at a cost of Rs.47.50 lakhs under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2016-2017, 2017-2018 and 2018-2019.

3. In the reference 3rd cited, the Principal Secretary / Commissioner, Department of Economics and Statistics has requested the Government to incur the expenditure Rs.4,50,000/- as maintenance fund for the Video Conferencing System.

4. The Government accordingly sanction a sum of Rs.4,50,000/- (Rupees Four Lakhs and Fifty thousand only) for maintenance fund for the Video Conferencing System under Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2017-2018.
