ORDER:

In the Government Order first read above, the Government of Tamil Nadu has sanctioned a sum of Rs.82,51,29,000/- as reimbursement of Tamil Nadu Value Added Tax (TNVAT) incurred by Chennai Metro Rail Limited from the inception till 31.3.2014 during 2014-2015, as per the provisions of Memorandum of Understanding entered between Government of India, Government of Tamil Nadu and Chennai Metro Rail Limited on 15.2.2011.

- 2. In the reference second read above, the Director-Finance, Chennai Metro Rail Limited has sent detailed proposal for reimbursement of Tamil Nadu Value Added Tax (TNVAT) of Rs.107,48,78,309 incurred from 01.04.2014 till 31.3.2016 along with an audit certification from the Chartered Accountants. As per the provisions of the Memorandum of Understanding entered between Government of India, Government of Tamil Nadu and Chennai Metro Rail Limited on 15.2.2011, the Director-Finance has requested the Government to issue orders for reimbursement of Tamil Nadu Value Added Tax (TNVAT) for Rs.107,48,78,309/- and to release a sum of Rs.57,64,00,000/- as grant as provided in the Budget Estimate for 2016-17.
- 3. The Government after careful consideration of the proposal of Director-Finance, Chennai Metro Rail Limited under provisions of Memorandum of Understanding entered between Government of India, Government of Tamil Nadu and Chennai Metro Rail Limited on 15.2.2011, has decided to release a sum of Rs.57,64,00,000/- as a part of the reimbursement claim made for the period upto 31.3.2016.

- 4. Accordingly the Government sanction a sum of Rs.57,64,00,000/- (Rupees Fifty seven crores and sixty four lakhs only) towards part of reimbursement of Tamil Nadu Value Added Tax (TNVAT) incurred from 01.04.2014 till 31.3.2016 as grant to Chennai Metro Rail Limited during 2016-17.
- 5. The expenditure sanctioned in para 4 above shall be debited to the head of account "2217 Urban Development 05 Other Urban Development Schemes 190 Assistance to Public Sector and Other Undertakings Schemes in the Twelfth Five Year Plan II State Plan JP Grant to Chennai Metro Rail Limited as reimbursement of taxes / duties levied by the State 09 Grant-in-Aid 03 Grants for Specific Schemes" (DPC 2217 05 190 JP 0939). Necessary funds have been provided in Revised Budget Estimate for 2016-17.
- 6. The Government also direct that the grant sanctioned in para 4 above will not be paid in cash but shall be credited into the PD Account in respect of Chennai Metro Rail Limited.
- 7. The Section Officer, Planning, Development and Special Initiatives (Bills) Department shall draw the grant sanctioned in para 4 above and contra-credited into the following head of account by means of a cheque drawn in favour of Public Deposit Account of "Chennai Metro Rail Limited" bearing Account No.30317331180.
