In the letter second read above, the Managing Director, Chennai Metro Rail Limited (CMRL) has suggested to include him as a "Member" in the High Power Committee on the grounds that at the time of constitution of High Power Committee and upto the end of 2013, the posts of the Secretary to Government, Special Initiatives and the Managing Director, Chennai Metro Rail Limited were held by the same Officer and that a separate Officer has been appointed as Managing Director to the Chennai Metro Rail Limited thereafter.
- 3. The Government after careful consideration of the proposal of the Managing Director, Chennai Metro Rail Limited has decided to accept the suggestion and accordingly, the following amendments are issued to para 4 (I) of the Government Order first read above:

AMENDMENT

- I. "Managing Director, Chennai Metro Rail Limited" shall be included as sl.no.10 under the caption "I. Composition of the Committee" in para 4 of the Government Order.
- II. The words, "other than the Managing Director" shall be inserted between the words "The Directors" and "representing" in the first line, below the foot note in para 4 (I) of the Government Order.
