ORDER

In the Government Order first read above, orders have been issued amending rule 4 of the Special Rules for Tamil Nadu Statistics Service (Section 26-A in Volume-II of the Tamil Nadu Services Manual, 1969) prescribing educational qualification for appointment as Assistant Director of Statistics by direct recruitment. In the reference second read above, orders have been issued prescribing yardstick to assess the candidates to be directly recruited for the post of Assistant Director of Statistics.

- 2. In the reference third read above, the Tamil Nadu Public Service Commission has informed the difficulties in scrutinizing the applications on the eligibility of candidates with reference to educational qualification specifically on the issue of ancillary subject in Statistics which resulted unwarranted communications to Universities concerned to ascertain the subject and degree awarded with different Universities with different curriculum and syllabus.
- 3. In this regard, the Sub-Committee formed by Tamil Nadu Public Service Commission to sort out the difficulties faced in finalizing and accepting qualification and experience of candidates for appointment of Assistant Director of Statistics by direct recruitment had convened a meeting on 03.01.2023 with the representatives from the Government and from the Head of Department concerned and wherein the issue referred by the Tamil Nadu Public Service Commission was discussed. The Committee accepted with consensus to amend the Special Rules regarding the appointment of Assistant Director of Statistics by direct recruitment.
- 4. Accordingly, in the reference fifth read above, the Additional Chief Secretary/ Commissioner (FAC), Department of Economics and Statistics has sent proposal for amendment to rule 4 of the Special Rules for Tamil Nadu Statistics Service prescribing educational qualification for appointment to the post of Assistant Director of Statistics by direct recruitment.
- 5. The Government after careful consideration, accept the proposal of the Additional Chief Secretary/ Commissioner (FAC), Department of Economics and Statistics and decided to issue suitable amendment to the rule 4 of the Special Rules for Tamil Nadu Statistics Service prescribing educational qualification for appointment to the post of Assistant Director of Statistics by direct recruitment.
- 6. The following notification will be published in the <u>Tamil Nadu Government Gazette</u>:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Statistics Service (Section 26 A in Volume-II of the Tamil Nadu Services Manual, 2016).

AMENDMENT

In the said Special Rules, in rule 4, in the TABLE, against the entry "Assistant Director of Statistics" in column (1) and the corresponding entry "Direct recruitment" in column (2) thereof, for item 2 including the proviso there under in column (3), the following item shall be substituted, namely:-

- "2. (i) Must hold a First Class Degree in Statistics or Mathematics or Economics or Applied Economics or Business Economics with not less than 60% marks or equivalent Cumulative Grade Point Average (CGPA); or
- (ii) Master's degree in Statistics or Mathematics or Economics or Applied Economics or Applied Statistics or Applied Mathematics or Business Economics or Operations Research or Mathematical Economics or Econometrics."
