ORDER:

In the Government order first read above, a State Statistical Committee was constituted and subsequently the State Statistical Committee was reconstituted in Government Orders 2nd, 3rd, and 4th read above with the functions to strengthen the inter departmental co –ordination for the effective use of Directorate of Economics and Statistics and the State Planning Commission.

2. In the letter fifth read above, the Member Secretary, State Planning Commission has requested the Government to reconstitute a State Statistical Committee with official and non-official members to act as a Technical Co-ordination Committee between the Department of Economics and Statistics and the State Planning Commission.

3. Government after careful consideration, reconstitute a State Statistical Committee under the Chairmanship of the Vice Chairman, State Planning Commission to primarily strengthen inter departmental co-ordination and to streamline the methodology and process of collecting, analysing and disseminating data among the various Departments of the State Government.

4. Proposed Composition of the Committee:

The Vice Chairman, State Planning Commission would be the Chairman of the State Statistical Committee. The composition of Members, both official and non-official is listed below:

The following are the Objectives of the State Statistical Committee:

1. To streamline the methodology of data management in the state.
2. To advise the Government Departments in the process of data collection, analysis, presentation, and dissemination to the public.
3. To provide guidance to the Department of Statistics in developing a framework for data management in the state.
4. To act as a platform for providing access to data which is being collected by various departments in the state.
5. To collect data from emerging sectors such as IT and Fintech and to publish interpretative statistical reports on specific sectors/ fields such as health, women etc.

NON-OFFICIAL MEMBERS:

Any two experts from the related domain shall be invited to participate in the meetings as co-opted members. The committee shall be treated as Class – I and the experts shall be eligible for TA/DA as per Government norms.

Functions of the Committee:

- 1) To advise the Government on
 - a) Data collection, tabulation and presentation
 - b) Training of staff members,
 - c) New initiatives on data collection and presentation and
 - d) Publication of interpretative reports and review the existing arrangements of preparation, collection, tabulation, analysis and dissemination of data under different statistical schemes and surveys implemented in the state by the Department of Economics and Statistics and other State Government Departments and agencies so as to improve the existing system.
- 2) To review and publish administrative data by individual Departments/ Sectors.
- 3) Advice on matters relating to creation of data warehouse.
- 4) Democratizing data sets for use of academics and professionals.
- 5) Periodic dissemination of data and advisory on specific themes through data analysis & to ensure that statistical reports of various government departments are available to the user organization, institution and public.
- 6) Setting protocols from data collection to authentication, storage and dissemination adhering to personal data privacy protocols.
- 7) To suggest effective coordination mechanism for ensuring integrated development of the decentralized statistical system.

- 8) To examine the availability of administrative statistics of various departments and to suggest ways and means for improving the administrative statistics so as to make them useful for policy decisions and planning purpose.
- 9) To improve statistical organization in policy and in decision making purposes.

The State Statistical Committee shall meet preferable once in every quarter. The Director, Department of Economics and Statistics would be the Member Convenor of the Committee. The above Committee shall be treated as a first class committee and all official and non official Members will be considered as Secretary of Departments for the purpose of allowances.
