Public Holiday for Muharram declared on 24.10.2015 under Negotiable Instruments Act 1881 – Orders – Issued.

ORDER:

In the Government Order first read above, the Government ordered that Friday the 23rd October 2015 as a Government Holiday for Muharram under Negotiable Instruments Act 1881. The Chief Kazi to the Government of Tamil Nadu in their letter 2nd read above has stated that the crescent of the lunar month of Muharram was not sighted on 13.10.2015 and that the "Yoem-e-Shahadath (10th day of Muharram) would be observed on Saturday, the 24th of October 2015 in Tamil Nadu and not on Friday, the 23rd of October 2015 and requested to declare the public holiday on Saturday the 24th of October 2015.

2. The Government after careful consideration of the matter have decided to declare 24th October 2015 as a Public Holiday for Muharram instead of 23rd October 2015 under Negotiable Instruments Act 1881. Accordingly, the following Notification will be published in an extra-ordinary Gazette dated 19.10.2015.

NOTIFICATION

3. Under the Explanation to Section 25 of the Negotiable Instruments Act 1881 (Central Act XXVI of 1881) read with Notification of the Government of India, Ministry of Home Affairs No.20-25-26, Public -1, dated 8th June 1957 the Government of Tamil Nadu hereby declares that Saturday the 24th of October 2015 would be a Public Holiday on account of Muharram instead of 23rd October 2015.

4. The above Public Holiday notified shall also apply to all State Government Undertakings/Corporations/Boards etc.,
