ORDER:

The Hon'ble Chief Minister of Tamil Nadu on 24th February 2022, had written a letter to the Hon'ble Union Minister for External Affairs for the safe rescue of Tamilians stranded in Ukraine in view of the Russian Military moved into Ukraine. In order to reach out to the students/NRTs and their families who are stranded in Ukraine and to facilitate and liaison with Government of India, the Government of Tamil Nadu has appointed a State Nodal Officer with a control room, in districts across the State the Personal Assistant (General) to the Collectors have been nominated has district nodal officers for this purpose. In New Delhi also, a control room has been opened 24X7 under the Additional Chief Secretary / Chief Resident Commissioner, Tamil Nadu House, with help lines to facilitate timely help to the students and NRTs.

- 2. The Hon'ble Chief Minister of Tamil Nadu on 3rd March 2022, has taken up a review over the action taken to rescue the students and NRTs from Ukraine from 24.2.2022 and ordered to depute State Representatives comprising the Members of Parliament / Member of Legislative Assembly along with Officers of IAS (TN Cadre) to the Countries neighbouring Ukraine (Slovakia, Hungary, Romania and Poland) to support evacuation of the students and NRTs of Tamil Nadu from Ukraine.
- 3. Accordingly, the Government nominates the representatives of the Government of Tamil Nadu to the neighbouring countries of Ukraine viz Slovakia, Hungary, Romania and Poland from where Indians are being evacuated by the Ministry of External Affairs, GOI via International flights, to support evacuation of students and NRTs of Tamil Nadu from Ukraine:

- 4. The Commissioner, Rehabilitation and Welfare of the Non-resident Tamils, Chennai is requested to make all necessary arrangements in consultation with the Additional Chief Secretary / Chief Resident Commissioner, Tamil Nadu House, New Delhi in connection with the travel of the State Representatives of the Government of Tamil Nadu to the neighbouring countries of Ukraine. The required expenses in connection with the visit of the State Representatives shall be met out from the funds of the State Government allocated to the Commissionerate of Rehabilitation and Welfare of the Non-resident Tamils.
- 5. The visit of the officers will commence from the date of departure from Chennai and end on the date their arrival at Chennai. The period of the tour of the officers will be treated as on duty and there are eligible for the pay and allowances, which they would have drawn in India but for their tour abroad.
