Public Holidays for the year 2018 – Public Holiday for all Commercial Banks and Co-operative Banks on 01.04.2018 (Sunday) – Cancelled and declared on 02.04.2018 (Monday) – Orders issued.

ORDER:

In the Government Order first read above, the Government ordered that Sunday the 1st April 2018 as Government Holiday for Commercial Banks and Co-operative Banks under Negotiable Instruments Act, 1881. In the reference second read above, the General Manager, Reserve Bank of India has requested to declare April 2, 2018 (Monday) as Holiday under the Negotiable Instruments Act, 1881 for the year 2018 for Annual Closing of Bank Accounts for Commercial and Co-operative Banks in Tamil Nadu in order to have uniformity in Annual Closing of Accounts among the banks across the Country, since April 01, 2018 falls on Sunday.

2. The Government, after careful consideration, have decided to declare 2nd April 2018 as Public Holiday for Commercial Banks and Co-operative Banks instead of 1st April 2018 under Negotiable Instruments Act, 1881. Accordingly, the following Notification will be published in an extra-ordinary Gazette dated:26.03.2018.

NOTIFICATION

Under the Explanation to Section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881) read with Notification of the Government of India, Ministry of Home Affairs No.20-25-26, Public -1, dated 8th June 1957, the Government of Tamil Nadu hereby declares that Monday the 2nd April 2018 would be a Public Holiday for Commercial Banks and Co-operative Banks in Tamil Nadu instead of 1st April 2018.
