ORDER:-

In the Government Order first read above Government have accorded administrative sanction for the work of Rehabilitation of old anicuts in Amaravathi river system of an estimate amount of Rs.18.00 Crore as a single package under NABARD loan assistance in RIDF XVII.

2. In the letter 2nd read above the Chief Engineer (Plan Formulation), Water Resources Department has stated that, under this scheme, 13 anicuts are to be rehabilitated and these anicuts are located at various places along the river Amaravathi which runs from the Dam at Amaravathinagar ('0' LS) to its confluence point with river Cauvery for a length of 228 Km. The distance between the anicuts ranges from 3 km and 16 km. The closure period in this system is two months and likely to be extended to four months (ie. April to July) and rehabilitation works are to be taken up in this short duration. Therefore, single package for Rs.1800 lakhs may result in slow progress and the completion will be getting delayed. Therefore, it is considered that this work can be split into 6 works as noted below for easy execution and for completion of the project in time and he has requested to issue necessary orders for splitting the works into the following 6 packages.
