ORDER:

On the floor of the Assembly on 02.09.2016, in respect of Demand No.38 of Public Department, the Hon'ble Chief Minister among others, has made the following announcement:-

"இராணுவத்தில் பணியாற்றி ஒய்வூதியத்துடன் படைப்பணியிலிருந்து விடுவிக்கப்பட்ட பின்னர், மறுவேலைவாய்ப்பு அடிப்படையில் குடிமைப் பணியில் வேலைவாய்ப்பு பெற்று, குடிமைப் பணிக்கான ஒய்வூதியமும் பெற்று உயிர்நீத்த தமிழ்நாட்டைச் சேர்ந்த முன்னாள் படைவீரர்களின் கைம்பெண்கள் மற்றும் வாரிசுதாரர்களுக்கு இராணுவ குடும்ப ஒய்வூதியத்துடன் குடிமைப் பணியில் பணியாற்றியமைக்கான குடும்ப ஒய்வூதியமும் வழங்கப்படும்.

01.04.2003—க்கு முன்பு, குடிமைப் பணியில் மறுவேலைவாய்ப்பு பெற்று, பணிபுரிந்து ஓய்வுபெற்ற பின்பு ஓய்வூதியம் பெற்றுள்ள முன்னாள் படைவீராகளின் குடும்பங்களுக்கு இது பொருந்தும்.

இதன் மூலம் மாநில அரசிற்கு ஆண்டு செலவினம் ரூ.55.75 இலட்சம் ஆகும்."

2. Based on the announcement, the Joint Director (i/c), Directorate of Ex-Servicemen's Welfare has sent the proposal in which he has informed that, the Principal Accountant General of Tamil Nadu in the letter second

read above, had addressed the Government of Tamil Nadu that since the Government of India vide O.M. dated 16.01.2013 have amended the CCS (Pension Rules) so as to enable the spouse of Central Government Employees to get two family pensions (i.e.) for both civil and military family pensions and also recommended that the Government of Tamil Nadu may consider issue of amendment to Rule 49 (13-B) of Tamil Nadu Pension Rules, 1978, so as to enable a spouse of State Government employee to draw two family pensions one for Military and another for services rendered under State Government.

- 3. The Joint Director (i/c), Directorate of Ex-Servicemen's Welfare has therefore requested the Government to issue orders for grant of dual family pension to the families of Ex-Servicemen who have been re-employed in Civil (i.e.) State Government Service and earned a pension out of the re-employment, prior to 01.04.2003 (i.e.) before the introduction of the Contributory Pension Scheme.
- 4. After careful examination, the Government has decided to accept the proposal of the Joint Director (i/c), Directorate of Ex-Servicemen's Welfare and accordingly order for the sanction of Dual Family Pension to those families of Ex-Servicemen who have been re-employed in Civil (i.e.) State Government Service and earned a pension out of the re-employment prior to 01.04.2003 (i.e.) before the introduction of Contributory Pension Scheme, in addition to Military Family Pension already drawn by them.
 - 5. This order shall take effect from 02.09.2016.
- 6. Necessary amendment to Rule-49 (13-B) of Tamil Nadu Pension Rules1978 shall be issued by Finance (Pension) Department separately,
- 7. This order issues with the concurrence of Finance Department vide it's U.O.No.15127/Pension/2017, dated. 31.03.2017.
