Under Clause (3) of Article 166 of the Constitution of India, the Governor of Tamil Nadu hereby directs that

iv) Thiru R.Doraikkannu shall continue to hold the portfolios of "Agriculture, Agricultural Engineering, Agro Service Cooperatives, Horticulture, Sugarcane Cess, Sugarcane Development and Waste Land Development". Thiru R. Doraikkannu be designated as Minister for Agriculture.
