**ORDER:**

iii) To allocate the portfolio Animal Husbandry hitherto held by Thiru P.Balakrishna Reddy to Thiru Udumalai K Radhakrishnan and to designate him as Minister for Animal Husbandry;

iv) To allocate the portfolio Youth Welfare and Sports Development hitherto held by Thiru K.A.Sengottaiyan to Thiru P.Balakrishna Reddy and to designate him as Minister for Youth Welfare and Sports Development;


