In the Government Order 3rd read above, orders have been issued that Thiru K.S. Sripathi, I.A.S., (Retd.), State Chief Information Commissioner, Tamil Nadu Information Commission ceases to hold office on attaining the age of sixty five years on 27.04.2015 as provided in sub-section (1) of Section 16 of Right to Information Act, 2005.

2. The Governor of Tamil Nadu has decided to appoint Thiru K. Ramanujam, IPS (Retd) as State Chief Information Commissioner in the Tamil Nadu Information Commission.

NOTIFICATION

In exercise of the powers conferred by sub-section (3) of section 15 of the Right to Information Act, 2005 (Central Act 22 of 2005), the Governor of Tamil Nadu hereby appoints Thiru K. Ramanujam, IPS (Retd) as State Chief Information Commissioner in the Tamil Nadu Information Commission.

4. The State Chief Information Commissioner shall hold office for a term of five years from the date on which he enters upon his office or the date on which he attains the age of sixty-five years, whichever is earlier.


