Military – Enhancement of payment of ex-gratia to the families of the Para Military Force Personnel [(BSF) (CRPF), (CISF), (ITBP) (SSB)] hailing from Tamil Nadu who are killed or incapacitated in action against enemy forces / counter insurgency operations / while performing duties in aid to Civil Power from the State Government Funds - Orders— Issued.

### ORDER :-

In the Government orders sixth read above, orders have been issued to revise the monetary grants payable to the Next of Kin of Defence Personnel who are killed / disabled in operations in border areas and also while performing duties in aid to civil power / internal security operations from the State Government Fund as detailed below:-

2. The Hon'ble Chief Minister of Tamil Nadu on 02.09.2016, while moving the Demand No 38, Public Department on the floor of the Assembly has announced that the monetary grants now enhanced to the Defence Personnel will also be extended to all the below mentioned Para Military Force Personnel hailing from Tamil Nadu:-

- A) Border Security Force (BSF)
- B) Central Reserve Police Force (CRPF)
- C) Central Industrial Security Force (CISF)
- D) Indo -Tibetan Border Police (ITBP),
- E) Sashastra Seema Bal (SSB)

3. As per the announcement made by the Hon'ble Chief Minister, the Government directs that the monetary grants now enhanced to the Defence Personnel shall be extended to all the Para Military Force Personnel such as Border Security Force (BSF), Central Reserve Police Force (CRPF), Central Industrial Security Force (CISF), Indo-Tibetan Border Police (ITBP) and Sashastra Seema Bal (SSB) hailing from Tamil Nadu those who are killed / incapacitated during operations in border areas / during Internal Security Operations / while performing duties in aid to civil power. The monetary grant enhanced are as follows:-

The ex-gratia of Rupees Twenty lakhs mentioned in Sl.No.1 above shall be paid to the legal heirs equally.

4. The Director of Ex-Servicemen's Welfare, Chennai-3, will sanction the monetary grant mentioned in the Paragraph 3 above and the Personal Assistant to the Director of Ex-Servicemen's Welfare, Chennai-3 is authorized to draw and disburse the monetary grant to the Next of Kin of those Para Military Force Personnel hailing from Tamil Nadu.

5. The expenditure shall be debited to "2235 Social Security and Welfare – 60 Other Social Security and Welfare Programmes – 200 Other Programmes – I. Non-Plan – BC – Extension of Battle Casualty facilities to the Dependants of those killed, disabled while performing duties in aid to civil power during peace time – 09 Grants-in-Aid – 09 Others (DP Code 2235 – 60 – 200 – BC – 0995)".
