NOTIFICATION

Under the Explanation to Section 25 of the Negotiable Instruments Act, 1881 (Central Act, XXVI of 1881), read with the Notification of the Government of India, Ministry of Home Affairs, No.20-25-26, Public-I dated the 8th June 1957 the Governor of Tamil Nadu hereby declares Thursday, the 21st December 2017, the date on which the poll for the Bye-election to Tamil Nadu Legislative Assembly from 11-Dr. Radhakrishnan Nagar Assembly Constituency will take place, to be a public holiday for the areas comprised in the above Assembly Constituency lying in Chennai District.

(2) Further, all employees working in Chennai and the neighbouring districts but registered as voters in 11-Dr. Radhakrishnan Nagar Assembly Constituency, shall also be given a paid holiday on 21.12.2017.

(3) All Government offices including industrial establishments of the Government and Government controlled bodies and all the educational institutions throughout the areas comprised in 11-Dr. Radhakrishnan Nagar Assembly Constituency lying in Chennai District will remain closed on 21.12.2017.
