The Chief Engineer (State Groundwater & Surface Water Resources Data Centre), has submitted a proposal for taking up the work of "Study of Groundwater assessment based on Mini Watershed in Tiruchy, Madurai, Erode, Karur, Tirunelveli and Virudhunagar at an estimated cost of Rs. 82.00 lakhs" under part – II Scheme for 2008-2009 in order to improve the over-exploited and critical blocks based on the priority studies, for which no additional staff is required.

- 2. The above proposal was approved by the Standing Finance Committee, under Part II Scheme for 2008-2009.
- 3. The Chief Engineer (Plan Formulation) has now forwarded the estimate for Rs.82.00 lakhs for the above scheme, as detailed below: -
