### **ORDER:**

Irrigated Agriculture Modernisation and Water-Bodies Restoration and Management (IAMWARM) Project is a Multi-Disciplinary project with the aim to improve the performance of Irrigated Agriculture along with restoration of Water Bodies and irrigation infrastructure in the State, with an outlay of 566 million US Dollars (Rs.2547.00 Crore), with the assistance of World Bank, has been implemented in three phases for the project period from 2007-2013. The Government constituted an Empowered Committee under the Chairmanship of Chief Secretary to consider and to clear the proposals received from the respective Departments / Multi Disciplinary Project Unit which require the orders of the Government inclusive of those involving financial expenditure by simplifying the procedure to avoid delay to be caused by the departmental scrutiny.

2. The Engineer-in-Chief, Water Resources Department has stated that the proposal for the Rehabilitation and Modernisation of System Tanks and Non-System Tanks and its Supply Channels under Cooum sub basin in Vellore, Kanchipuram and Thiruvallur Districts of Chennai Region (7 packages) including Environment component at an estimated cost of Rs.2240.56 lakhs was circulated among the members of the Empowered Committee and cleared on 4.5.2011.

3. Based on the approval of the Empowered Committee the Engineer-in-Chief, Water Resources Department has sent proposals for administrative sanction for a sum of Rs.2240.56 lakhs in respect of 7 packages / estimates for the work of Rehabilitation and Modernisation of system tanks and Non system tanks and its supply channels under Cooum sub-basin in Vellore, Kanchipuram and Thiruvallur Districts.

4. The Overall project outlay of IAMWARM Project under the component `A` and the fund availability particulars are as detailed below:-

In the Circumstances the Engineer-in-Chief, Water Resources Department has requested necessary Administrative sanction for a sum of Rs.2240.56 lakhs in respect of 7 packages / estimates for the work of Rehabilitation and Modernisation of system tanks and Non system tanks and its supply channels under Cooum sub-basin in Vellore, Kanchipuram and Thiruvallur Districts.

6. The Government after careful consideration accept the proposals of the Engineer-in-Chief, Water Resources Department as approved by the Empowered Committee and accord Administrative sanction for the 7 packages of the work of Rehabilitation and Modernisation of system tanks and Non system tanks and its supply channels under Cooum sub basin in Vellore, Kanchipuram and Thiruvallur Districts under the IAMWARM Project at an estimated cost of Rs.2240.56 lakhs (Rupees Two thousand two hundred forty lakhs and fifty six thousand only) as detailed in the annexure to this order.

7. The Engineer-in-Chief, Water Resources Department and the Chief Engineer, Water Resources Department, Chennai Region are instructed to ensure that there should be no overlapping / duplication of work of rehabilitation with the recently implemented projects, such as Water Resources Consolidation Project.

8. The expenditure sanctioned in para 6 above shall be debited to the following Heads of Account:-

Pending approval of the legislature, the expenditure will be initially met by drawal of an advance from contingency fund, orders regarding which will be issued by Finance (BG-I) Department separately. The Engineer-in-Chief, Water Resources Department, Chennai-5 is requested to send necessary proposals to Government in Finance (BG-I) Department in the prescribed format, along with a copy of this order for sanction of an advance from the Contingency Fund. He is also requested to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates to Finance (BG-I) Department at an appropriate time.

10. This order issues with the concurrence of Finance department vide its U.O.No. 121/DS(B)/PWII/2011, dated 28.07.2011 and Additional Sanction Ledger No.321 (Three Hundred and Twenty One).
