ORDER:

The Chief Engineer (Buildings) has stated that the Xerox machines available at the office of the Chief Engineer (Buildings) are beyond repairs and they need to be condemned. Hence he has proposed to replace the same with Digital Duplicator, Computer Compatible for High Speed Printing and Automatic Master Printer with Scanning and Thermal Screening System at an estimate of Rs.4.80 lakhs (Rupees Four lakhs and eighty thousand only) for the use of the office of the Chief Engineer (Buildings) and has requested the approval of the Government.

2. The above proposal was placed before the Standing Finance Committee and the Standing Finance Committee has also approved the proposal under Part II Schemes for 2008-2009.

3. The Government accordingly accord administrative sanction for a sum of Rs.4.80 lakhs (Rupees Four lakhs and eighty thousand only) for the purchase of Digital Duplicator, Computer Compatible for High Speed Printing and Automatic

Master Printer with Scanning and Thermal Screening System for the use of the office of the Chief Engineer (Buildings) under Part II Schemes for the year 2008-2009.

4. The expenditure sanctioned in para 3 above shall be debitable to the following head of account.
