#### ORDER:

The Irrigated Agriculture Modernisation and Water-Bodies Restoration and Management (IAMWARM) Project, a Multi-Disciplinary project with the aim to improve the performance of Irrigated Agriculture along with restoration of Water Bodies and irrigation infrastructure in the State, with an outlay of 566 million US Dollars (Rs.2547.00 Crore), with the assistance of World Bank, has been implemented in three phases for the project period from 2007-2013. Empowered The Government constituted an Committee under the Secretary to consider and to clear the proposals Chairmanship of Chief received from the respective Departments / Multi Disciplinary Project Unit which require the orders of the Government inclusive of those involving financial expenditure by simplifying the procedure to avoid delay to be caused by the departmental scrutiny.

2.In the letter second read above, the Engineer-in-Chief, Water Resources Department has stated that the Empowered Committee has approved the proposal for 6 packages of the work of Rehabilitation and Modernisation of all tanks and supply channels under Paralaiyar Sub Basin in Sivagangai, Virudhunagar and Ramanathapuram Districts including Environment Component, at an estimated cost of Rs.3186.60 lakhs and requested Administrative Sanction for the above proposal.

3. The Government, after careful consideration, have decided to accept the proposal of the Engineer-in-Chief, Water Resources Department as approved by the Empowered Committee and accord Administrative Sanction for the six packages of

the work of Rehabilitation and Modernisation of System and Non-system tanks and its supply channels under Paralaiyar Sub Basin of Sivagangai, Virudhunagar and Ramanathapuram Districts of Madurai Region at an estimated cost of Rs.3186.60 lakhs (Rupees Three thousand one hundred eighty six lakhs and sixty thousand only) as detailed in the Annexure to this order.

4.The Engineer-in-Chief, Water Resources Department and the Chief Engineer, Water Resources Department, Madurai Region are instructed to ensure that there should be no overlapping / duplication of work of rehabilitation with the recently implemented projects, such as Water Resources Consolidation Project.

5. The expenditure sanctioned in para 3 above shall be debitable under the following Heads of Account:-

"4701 - Capital outlay on Major and Medium Irrigation – 03 Medium Irrigation – Commercial - 425 Renovation of Dam, Canal and Tanks of Paralaiyar Sub basin under Tamil Nadu IAMWARM Project - PA. Renovation of Tanks in Paralaiyar Sub basin under Tamil Nadu Irrigated Agriculture Modernisation and Water Bodies Restoration and Management Project (TN IAMWARM) - 16 Major Works (DPC 4701 03 425 PA 1603)."

and

"2701 – Major and Medium Irrigation - 03 Medium Irrigation Commercial - 204 Rehabilitation of works under IAMWARM Project - Schemes in the Eleventh Five Year Plan - II State Plan - PE Environmental activities under Tamil Nadu IAMWARM Project - 33 Payments for Professional and Special services -03 Special Services (DPC 2701 03 204 PE 3338)."

6. The expenditure sanctioned in para 3 above constitutes an item of "New Instrument of Service". The approval of the legislature will be obtained in due course. Pending approval of the legislature, the expenditure will be initially met by drawal of an advance from contingency fund, orders regarding which will be issued by Finance (BG-I) Department separately. The Engineer-in-Chief, Water Resources Department, Chennai-5 is requested to send necessary proposals to Government in Finance (BG-I) Department in the prescribed format, along with a copy of this order for sanction of an advance from the Contingency Fund. He is also requested to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates to Finance (BG-I) Department at an appropriate time.

7. This order issues with the concurrence of Finance department vide its U.O.No. 120/DS(B)/PWII/2011, dated 28.07.2011 and additional sanction Ledger No.322 (Three Hundred and Twenty Two).
