

Public Works Department-Buildings-Part II Schemes for the year 2008-2009-Purchase of 17 Nos. of New Vehicles (Jeeps) at an estimate of Rs.80.75 lakhs for Public Works Department Divisions (Buildings Organisation) on replacement basis – Orders –Issued.

ORDER:

The Chief Engineer (Buildings) has stated that the Building Organisation is functioning with 50 Divisions and 188 Sub Divisions to execute works not only of this department but also of the other departments in the State. All the Executive Engineers and Assistant Executive Engineers numbering 238 officers are eligible for motor vehicles. However presently 38 Petrol Jeeps and 93 Diesel Jeeps are under use. Most of these vehicles are of more than 30 years old, and these vehicles need to be reeplaced. Out of 131 vehicles, condemnation proposal have been received for 17 vehicles. Hence, the Chief Engineer (Buildings) has proposed to purchase 17 Nos. of new vehicles (Jeeps) on replacement basis and has requested the approval of the Government.

2. The above proposal was placed before the Standing Finance Committee and the Standing Finance Committee has also approved the proposal under Part II Schemes for 2008-2009. 3. The Government accordingly accord administrative sanction for a sum of Rs.80.75 lakhs (Rupees Eighty lakhs and seventy five thousand only) for the purchase of seventeen new vehicles (Jeeps) for Public Works Department Divisions (Building Organisation) on replacement basis, under Part II Scheme for the year 2008-2009.

4. The expenditure sanctioned in para 3 above shall be debitable to the following head of account.

2059 – Public Works –80-General-001-Direction and Administration –I Non-Plan AA – Chief Engineers –21-Motor Vehicles –01 Purchase. (D.P.Code 2059-80-001-AA-2114)

5. The Chief Engineer (Buildings), Public Works Department is authorised to incur the expenditure as per the existing procedure. The estimates submitted by the Chief Engineer (Buildings) in his letter 3rd read above is also approved. A copy of the estimate is also returned herewith.
