ORDER:

The Chief Engineer (Buildings) has stated that the Division office at Coimbatore for which the AC roof building was constructed during 1895 is functioning. This building was originally used as garages which was converted into office due to constraint of space. This building does not have any heritage value and it is beyond repair. All the building construction works and maintenance works in Coimbatore District are being executed by this Division. Hence, in order to accommodate the Division Office in a building having minimum basic amenities, it has been proposed to dismantle the old building and construct a new office building for the Executive Engineer, Public Works Department Buildings (C&M) Division, Coimbatore at a cost of Rs.36.50 lakhs and he has stated that the estimate is prepared by adopting schedule of rates for the year 2008-2009. He has therefore requested the administrative sanction of the Government for the above work.

2. The above proposal was placed before the Standing Finance Committee and the Standing Finance Committee has also approved the proposal under Part II Schemes for 2008-2009.

3. Accordingly, the Government accord administrative sanction for a sum of Rs.Rs.36.50 lakhs (Rupees Thirty Six lakhs and fifty thousand only) for construction of Division office building for Executive Engineer, Public Works Department Buildings (C&M) Division, Coimbatore under Part II Scheme for the year 2008-2009, subject to the condition that the provision for P.S. charges, contingencies and unforeseen expenses, together should not exceed 2.5% of cost of works.

4. The expenditure sanctioned in para 3 above shall be debitable to the following head of account.

4059 capital outlay on Public Works – 01 Office Buildings 051 – Construction scheme in the Eleventh Five Year Plan II State Plan – JJ Public Works 16 Major Works (DPC 4059-01-051-JJ 1605).

5. The Chief Engineer (Building) is authorised to incur the expenditure as per the existing procedures. The estimate furnished by the Chief Engineer (Buildings) in the letter 3rd read above is also approved.

6. This order issues with the concurrence of Finance Department vide its U.O.No.157/DS(AR)/2008-1, dated 2.5.2008.
