## ORDER:

The Chief Engineer (Buildings) has stated that V.V.I.P's and senior officers, frequently visiting Chidambaram, Sirkali and Puducherry prefer to stay at Cuddalore. The existing Circuit House, constructed during 1980-1981 has only 4 Suites and these too are not upto desired standards. It is always felt that the existing accommodation in the Circuit House both in terms of quality and availability is not found adequate. In order to provide accommodation for the visiting dignitaries and easing the demand, he has proposed to construct an additional Circuit House at Cuddalore at a cost of Rs.48.00 lakhs. Sufficient land is available in the existing Circuit House campus itself. The Chief Engineer (Buildings) has stated that the estimate has been prepared by adopting schedule rates for the year 2008-2009. He has therefore requested the administrative sanction of the Government for the above work.

2. The above proposal was placed before the Standing Finance Committee and the Standing Finance Committee has approved the proposal under Part II Schemes for 2008-2009.

- 3. Accordingly, the Government accord administrative sanction for a sum of Rs.48.00 lakhs (Rupees forty eight lakhs only) for construction of Additional four suites for Circuit House at Cuddalore under Part II Scheme for the year 2008-2009, subject to the condition that P.S. charges, contingencies and unforeseen expenses together should not exceed 2.5% of cost of work. The expenditure for the above scheme for the year 2008-2009 is to Rs.36.00 lakhs (Rupees thirty six lakhs only).
- 4. The expenditure sanctioned in para 3 above shall be debitable to the following head of account.:-

4059 Capital outlay on Public Works – 01 Office Buildings 051 – Construction Scheme in the Eleventh Five Year Plan II State Plan – JJ Public Works 16 Major Works (DPC 4059-01-051-JJ1605).

- 5. The Chief Engineer (Buildings) is authorised to incur the expenditure as per the existing procedures. The estimate furnished by the Chief Engineer (Buildings) in his letter 3<sup>rd</sup> read above is also approved.
- 6. This order issues with the concurrence of Finance Department vide its U.O.No.156/DS(AR)/PW-I/2008-1, dated 2.5.2008.
