<u>ORDER</u>

The Engineer-in-Chief, Water Resources Organisation and Chief Engineer (General), Public Works Department has sent a proposal seeking Administration Sanction for the work of improvements, rehabilitation and beautification of Parks and Lawns in Sathanur Reservoir Project Dam, Thiruvannamalai District at an estimated amount of Rs.50.00 lakhs (Rupees Fifty Lakhs only) under Part-II schemes for the year 2007-08.

- 2. The Engineer-in-Chief has stated that the Sathanur Dam was constructed during the year 1954-1958 and that in the dam area 31 Parks are maintained and that by implementing this scheme more Tourists will be attracted and this would also help to protect the environment and further that the revenue realised from collection of entrance tickets from the visitors will also increase considerably.
- 3. The estimate has been prepared based on local market rates. The total cost of the proposals works out to Rs.50.00 lakhs.
- 4. The overall Sanction for providing infrastructure facilities and improvements of Park areas in the Dam sites of Sathanur, Krishnagiri, Bhavani Sagar, Mettur and Kelavarapalli are Rs.250.00 lakhs. The above proposal has been approved under Part-II schemes for year 2007-2008 by the Standing Finance Committee with an estimate amount Rs.250.00 lakhs.

- 5. Accordingly, the Government after careful consideration accord Administrative sanction for providing infrastructure facilities and improvements, to the Park areas in the Dam sites of Sathanur, Thiruvannamalai District at an estimated amount of Rs.50.00 lakhs (Rupees Fifty lakhs only) under Part-II scheme for the year 2007-2008.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following head of account 4701-Capital out lay on Major and Medium Irrigation 03 Medium Irrigation Commercial -315 Improvements and beautification of Parks in and around Reservoirs in Tamil Nadu -Schemes in the Eleventh Five Year Plan II State Plan JA Improvements and Beautification of Parks in and around Reservoirs in Tamil Nadu 16 Major Works (DPC:4701-03-315-JA-1602)".
- 7. The Estimate received with the letter second read above is approved and forwarded to the Chief Engineer, Chennai Region, Water Resources Organisation, Public Works Department. He is requested to take up the work immediately not exceeding the administrative sanction approved in para 5 above and send a periodical report on the progress of the work every month to the Government.
