ORDER:

The Chief Engineer (Buildings) has stated that Thoothukudi is the District headquarters besides being an important Port Town. The present Circuit House is situated near the Port, which is considered to be a largely polluted area. As several V.V.I.P's and senior officers often visit Thoothukudi. The Chief Engineer (Buildings) has proposed to construct an Additional Circuit House with five suites in the Master Plan Complex at Thoothukudi at an estimated cost of Rs.60 lakhs. The estimate is prepared by adopting schedule rates for the year 2008-2009. The Chief Engineer (Buildings) has therefore requested administrative sanction for the above work.

2. The above proposal was placed before the Standing Finance Committee and the Standing Finance Committee has also approved the proposal under Part II Scheme for 2008-2009.

3. The Government accordingly accord administrative sanction for a sum of Rs.60.00 lakhs (Rupees Sixty lakhs only) for Construction of Additional

Circuit House with five suites at Thoothukudi under Part II Scheme for the year 2008-2009. Orders regarding the exact location of the Additional Circuit House at Thoothukudi will be issued separately. The expenditure for the above scheme for the year 2008-2009 will be Rs.45.00 lakhs (Rupees Forty five lakhs only).

4. The expenditure sanctioned in para 3 above shall be debitable to the following head of account :-

4059 Capital Outlay on Public Works – 01 Office Buildings - 051 – Construction - Schemes in the Eleventh Five Year Plan-II State Plan – JJ Public Works - 16 Major Works (DPC 4059-01-051-JJ 1605).

5. The Chief Engineer (Building) is authorised to incur the expenditure as per the existing procedure subject to the condition that the provisions for P.S. charges, contingencies and other unforeseen charges together should not be exceeded 2.5% of the cost of works. The estimate furnished by the Chief Engineer (Buildings) in his letter third read above is also approved. A copy of the estimate is returned herewith.

6. This order issues with the concurrence of Finance Department vide its U.O.No.210/DS AR/2008, dated 2.6.2008.
