## ORDER:

The Engineer-in-Chief, Water Resources Organisation and Chief Engineer (General), has sent a proposal to the Government for "Construction of an anicut across Mukthanadhi to feed Kumarapalayam supply channel near Karadichittur Village in Kallakurichi Taluk of Villupuram District" at an estimated cost of Rs.25.70 Lakhs under Part II schemes for the year 2007-08.

2.The Engineer-in-Chief has reported that the schemes contemplates for the construction of an anicut across Mukthanadhi river. The anicut is proposed in between the existing Karadichittur anicut and Thavadipattu anicut in Mukthanadhi. Mukthanadhi after some distance confluences with Maninadhi and runs as Manimukthanadhi below the Manimukthanadhi Reservoir. The anicut is proposed for assured supply of water to Kumarapalayam channel. The Kumarapalayam supply channed draws water from Mukthanadhi as an open off take having registered ayacut of 48.54 Ha(120 acres). By implementing this scheme, the average gap noticed will be bridged to an extent of 46.10 ha, thereby stabilizing the balance registered ayacut and there is no land acquisition involved in this connection. The Benefit cost ratio will be 3.25:1.

3.The above scheme has been approved by the Standing Finance Committee under Part II scheme for 2007-2008. Accordingly, the Government after careful examination, accord Administrative Sanction for " Construction of an anicut across Mukthanadhi to feed Kumarapalayam supply channel near Karadichittur Village in Kallakurichi Taluk of Villupuram District with an ultimate cost of Rs.25.70 Lakhs (Rupees Twenty Five lakhs and Seventy thousand only). The expenditure for the above scheme during 2007-2008 is restricted to Rs.7.00 lakhs (Rupees Seven lakhs only).

4.The expenditure sanctioned in para 3 above shall be debited to the following head of account "4702-00 Capital Outlay in Minor Irrigation - 101. Surface Water - Schemes in ther XI Five Year Plan -II - State Plan - J.A. - Special Minor Irrigation Programme - 16 Major Works " (DPC 4702-00-101-J.A.-1607).

5.The Chief Engineer (Chennai Region), Water Resources Organisation, Public Works Department is requested to take up the work immediately and to send a periodical report on the progress of the work, every month to the Government.
