From the Chief Engineer, Water Resources Department, Plan Formulation letter No.F/7575/Part.II / 2010-2011, dated 27.01.2010.

ORDER:

The Chief Engineer, Water Resources Department, Plan Formulation in his letter read above has stated that there are number of anicuts across Santhanavarthini river. These anicuts play a vital role in the system. Uppukulam is one of the tanks benefited by Santhanavarthini river. This tank does not receive water even in the flood season, since the level of river is much lower than the sill level of the off take channel. He has also stated that it is proposed to construct an anicut across Santhanavarthini river so as to supply water through channel to Uppukulam tank. By implementing this scheme, an extent of 39.99 acres will be benefited. The cost of this scheme for the schedule of rates 2010-2011 works out to Rs.37.00 lakhs. The work will be executed by the Chief Engineer, Water Resources Department, Coimbatore Region. Hence no additional staff will be required for executing the scheme.

2. The above scheme is approved by the Standing Finance Committee under Part II Schemes for the year 2010-2011. Accordingly, the Government accord administrative sanction for the construction of Uppukulam anicut across Santhanavarthini river in Vembarpatti village of Dindigul Taluk and District at a cost of Rs.37.00 lakhs (Rupees Thirty seven lakhs only). Petty Supervision charges and unforeseen items should not exceed 2.5% of total cost of works.

3. The expenditure sanctioned in paragraph 2 above, shall be debited to the following head of account:-

“4702 – Capital Outlay on Minor Irrigation – 101. Surface Water – Schemes in the Eleventh Five Year Plan- II. State Plan – JA. Special Minor Irrigation Programme – 16. Major Works” (DP code 4702 – 00 –101 – JA 1607).

4. The Chief Engineer, Water Resources Department, Coimbatore Region is requested to take up the work immediately and complete it within the cost and time limit. He is also requested to send the progress of the work to the Government, every month, periodically.
