ORDER:-

The Chief Engineer (Plan Formulation), Water Resources Department has sent the estimate for the work of Rehabilitation works in Kondamari Odai in Madurai District for an amount of Rs.10.00 Crore based on the schedule of rates 2010-2011 along with provision for escalation for the year 2011-2012 and he has requested to accord administrative sanction for the same under NABARD loan assistance in RIDF XVII. This proposal has been forwarded to NABARAD for loan assistance.

2. In the letter 1st read above the Chief Engineer, Plan Formulation has stated that the Kondamari Odai starts from Sirumalai hills of Western ghats at an altitude of +896.000 m as two arms and emerges into plains. Both the arms join the main odai below Siruvalai west tank of Siruvalai village. The odai runs for a length of about 16.78 Kms and finally joins with the river Vaigai. There are 7 anicuts across this Odai which in turn feed the nearby tanks. This odai also receives flood surplus from the tanks during monsoon period. During rainy season, flood water enters into Madurai Sellur area breaching Vilangudi tank, Thathaneri tank and Sellur tank since this odai is not able to carry the flood and the water out flanks and spreads over its side banks. The anicuts in this Odai are also badly damaged and the tanks fed by this anicuts do not receive adequate supply. Hence it is proposed to rehabilitate the Odai and its anicuts to ensure commandability of the tanks fed by Kondamaari Odai and to carry the flood water and dispose into Vaigai River without any inundation in the adjoining villages. By implementing this scheme a total avacut of 1923.33 hectare will be benefitted by stabilizing 814.50 hectare besides bridging a gap of 1108.88 hectare. No land acquisition is involved in this scheme.

- 3. The following components are proposed in the estimate.
 - 1. Rehabilitation of Kondamari Odai by standardization and formation of bunds.
 - 2. Reconstruction of anicuts which are badly damaged.
 - 3. Repair to the tank weirs wherever necessary.
 - 4. Construction of retaining wall near Paravai Bed dam.

4. In the letter 2nd read above the NABARD has now approved the 12 irrigation schemes at a cost of Rs.4781.00 lakhs. Among these 12, the Rehabilitation works in Kondamari Odai in Madurai District at a cost of Rs.10.00 Crore is also one of the schemes. NABARD has provided Rs. 950.00 lakh (95%) as the loan assistance and the balance amount of Rs.50 .00 lakh (5%) as state share.

5. The Government, after careful examination, decided to accept the proposal of the Chief Engineer (Plan Formulation), Water Resources Department and accord administrative sanction for the work of Rehabilitation works in Kondamari Odai in Madurai District at an estimated cost of Rs.10,00,00,000/- (Rupees Ten crore only) with NABARD loan assistance of Rs.950.00 lakh (Rupees Nine crore and fifty lakhs only) with the state share of Rs.50.00 lakh (Rupees Fifty lakh only) under RIDF XVII.

6. The expenditure towards the work sanctioned in para 5 above shall be debited to the following new head of account, opened under Demand No.40.01:-

"4701- Capital Outlay on Major and Medium Irrigation – 03 Medium Irrigation-Commercial – 345 – Medium irrigation schemes – Schemes in the Eleventh Five Year Plan –II –State Plan- KD- Rehabilitation works in Kondamari Odai in Madurai District with Loan assistance from NABARD under RIDF XVII -16 Major works." (DPC .4701 -03 – 345-KD - 1602).

7. The Engineer-in-Chief, Water Resources Department is the Estimating, Reconciling and Controlling authority for the above new sub-head of account.

8. The Pay and Accounts Officer /Treasury Officers concerned are requested to open the above new Sub-Head of Account in their accounts.

9. The expenditure towards the work sanctioned in para 5 above constitutes an item of "New Service" for which the approval of the Legislature will be obtained in due course. Pending approval of the legislature, initially the expenditure will be met by drawal of an advance from the Contingency Fund, orders regarding which will be issued by the Government in Finance (BG-I) Department separately. The Engineerin-Chief, Water Resources Department, Chennai-5 is directed to send a proposal to Government in Finance (BG-I) Department in the prescribed format, along with a copy of this order for sanction of an advance from the Contingency Fund. Further, he is also requested to send necessary draft explanatory notes for the inclusion of the above expenditure in the Supplementary Estimates for the year 2011-2012 without fail at the appropriate stage. 10. This order issues with the concurrence of the Finance Department vide its U.O. No. 201/DS(B)/PWII/2011 dated: 12.12.2011 and Additional Sanction Ledger No. 1069 (One thousand and sixty nine).
