#### **ORDER:-**

The Chief Engineer (Plan Formulation), Water Resources Department has sent the estimate for the work of Rehabilitation of Sempoondi anicut across Kiliyar River at Kiliyanagar village of Madurantakam Taluk in Kancheepuram District for an amount of Rs.2.20 Crore based on the schedule of rates 2010-2011 along with provision for escalation for the year 2011-2012 and he has requested to accord administrative sanction for the same under NABARD loan assistance in RIDF XVII. This proposal has been forwarded to NABARAD for loan assistance.

- 2. In the Government Order first read of above а sum Rs. 1.00 crore has been sanctioned for Rehabilitation of Sempoondi anicut across Kiliyar River at Kiliyanagar village of Madurantakam taluk in Kancheepuram district under Part II schemes for the year 2009-2010. In his letter 2<sup>nd</sup> read above the Chief Engineer (Plan Formulation) has stated that Design approval has been obtained from the Chief Engineer, (DRCS), Water Resources Department on 4.2.2010 before the Technical sanction of the estimate. As per the design, 4 Nos. of scour vents of size 2.10x1.20 m provided on both sides of anicut, launching apron also provided in upstream and downstream sides of anicut, including some more infrastructures provided in the design resulting that the cost of estimate works out to Rs.2.05 Crore. Accordingly, the Revised Estimate has been prepared and sought to Revised Administrative Sanction for Rs.2.05 Crore and subsequently the estimate has been revised into Rs. 2.20 crore due to recosted the rate with escalation for the year 2011-2012.
  - 3. The following provisions are made in the estimate.
    - 1. 4 Numbers of scour vents of size 2.10m x 1.20 m provide in the both sides of anicut.

- 2. Launching apron also provided in Upstream and downstream sides of anicut.
- 3. Body wall of the anicut for a length 95m.
- 4. Desilting of the supply channel and Toe wall construction in Upstream and Downstream side of Head Sluice.
- 5 The abutment wings and returns are proposed in Cement Concrete M15 grade for left and right end of anicut body wall portion.
- 4. In the letter 3<sup>rd</sup> read above, the NABARD has now approved the 12 irrigation schemes at a cost of Rs.4781.00 lakhs. Among these 12, the Rehabilitation of Sempoondi anicut across Kiliyar River at Kiliyanagar village of Madurantakam taluk in Kancheepuram district for an amount of Rs.2.20 Crore is also one of the schemes. NABARD has provided Rs.209.00 lakh (95%) as the loan assistance and the balance amount of Rs.11.00 lakh (5%) as state share.
- 5. The Government, after careful examination, decided to accept the proposal of the Chief Engineer (Plan Formulation), Water Resources Department and accord administrative sanction for the work of Rehabilitation of Sempoondi anicut across Kiliyar River at Kiliyanagar village of Madurantakam Taluk in Kancheepuram District at an estimated cost of Rs.2,20,00,000/- (Rupees Two crore and Twenty lakhs only) with NABARD loan assistance of Rs.209.00 lakh (Rupees Two crore and nine lakh only) with the state share of Rs.11.00 lakh (Rupees Eleven lakh only) under RIDF XVII.
- 6. The expenditure towards the work sanctioned in para 5 above shall be debited to the following new head of account, opened under Demand No.40.01:-
  - "4701- Capital Outlay on Major and Medium Irrigation 03 Medium Irrigation-Commercial 345 Medium irrigation schemes Schemes in the Eleventh Five Year Plan –II –State Plan- JY- Rehabilitation of Sempoondi anicut across Kiliyar River at Kiliyanagar village of Madurantakam Taluk in Kancheepuram District with Loan assistance from NABARD under RIDF XVII -16 Major works." (DPC 4701-03–345-JY -1601).
- 7. The Engineer-in-Chief, Water Resources Department is the Estimating, Reconciling and Controlling authority for the above new sub-head of account.
- 8. The Pay and Accounts Officer /Treasury Officer concerned are requested to open the above new Sub-Head of Account in their accounts.
- 9. The expenditure towards the work sanctioned in para 5 above constitutes an item of "New Service" for which the approval of the Legislature will be obtained in due course. Pending approval of the legislature, initially this expenditure will be met by the drawal an advance from the Contingency Fund, orders regarding which will be issued by the Government in Finance (BG-I) Department separately. The Engineer-in-Chief, Water Resources Department, Chennai-5 is directed to send a proposal to

Government in Finance (BG-I) Department in the prescribed format, along with a copy of this order for sanction of an advance from the Contingency Fund. Further, he is also requested to send necessary draft explanatory notes for the inclusion of the above expenditure in the Supplementary Estimates for the year 2011-2012 without fail at the appropriate stage.
