The following Notification will be published in the <u>Tamil Nadu</u> <u>Government Gazette</u>:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Engineering Subordinate Service (Section 8 in Volume III of the Tamil Nadu Service Manual, 1970).

The amendment hereby made shall come into force with effect on and from the date of issue of this order.

AMENDMENT.

In the said Special Rules, in Part II, under the heading "Branch I - Engineering Branch", in Schedule II, for the entries in column (2) against the entry "Assistant Draughtsman" in column (1) thereof, the following entries shall be substituted, namely,-

- "(i) A pass in the Trade Test Draughtsman Course, namely National Trade Certificate or National Apprenticeship Certificate in the Industrial Training Institute conducted by the Director of Employment and Training, Chennai and issued by the Government of India, Ministry of Labour, National Council for Vocational Training; or
- (ii) Diploma in Civil, Mechanical, Electrical or in Architecture awarded by the State Board of Technical Education and Training, Chennai".
