ORDER:-

The Chief Engineer (Plan Formulation), Water Resources Department has sent the estimate for the work of Rehabilitation and Improvements to 16 anicuts in Kallar river of Vaniar Minor Basin in Pappireddypatty Taluk of Dharmapuri District for an amount of Rs.2.15 Crore based on the schedule of rates 2010-2011 along with provision for escalation for the year 2011-2012 and he has requested to accord administrative sanction for the same under NABARD loan assistance in RIDF XVII. This proposal has been forwarded to NABARD for loan assistance.

- 2. In the reference letter first read the Chief Engineer, (Plan Formulation) has stated that the river Kallar, a tributary of Vaniar originate from Mookanur hill ranges of Pappireddyapatty taluk of Dharmapuri District. There has an jungle stream namely, Jalakandeswar river and another jungle stream joins in the right bank of Kallar river. There are 14 anicuts across Kallar and one anicut across Jalakandeswar and another one across jungle stream. All the 16 anicuts are in damaged condition, due to lack of maintenance fund.
 - 3. The scheme contemplates to rehabilitates and improves the anicut system which is as follows.
 - 1. Desilting of anicut portion and Channel.
 - 2. Providing skin wall to arrest leakages.
 - 3. Repairs to the disturbed, Talus apron, solid aprons and providing downstream cut-off wall whether necessary.
 - 4. Repairs to off-take sluices and shutters.
 - 5. Construction of new head sluices with shutters where existing open of take.

- 6. Providing bank protection wall wherever necessary.
- 7. Repairing the cross-masonry works in the irrigation channel.
- 8. Providing selective lining in the irrigation channel, wherever necessary.
- 9. Providing foot path crossing, road culverts etc.
- 4. In the letter 2nd read above the NABARD has now approved the 12 irrigation schemes at a cost of Rs.4781.00 lakhs. Among these 12, the Rehabilitation and Improvements to 16 anicut in Kallar river of Vaniar Minor Basin in Pappireddypatty taluk of Dharmapuri District at a cost of Rs.2.15 crore under NABARD assistance is also one of the schemes. NABARD has provided Rs. 204.25 lakh (95%) as the loan assistance and the balance amount of Rs.10.75 lakh (5%) as state share.
- 5. The Government, after careful examination, decided to accept the proposal of the Chief Engineer (Plan Formulation), Water Resources Department and accord administrative sanction for the work of Rehabilitation and Improvements to 16 anicut in Kallar river of Vaniar Minor Basin in Pappireddypatty Taluk of Dharmapuri District at an estimated cost of for Rs.2,15,00,000/- (Rupees Two crore and fifteen lakh only) with NABARD loan assistance of Rs.204.25 lakh (Rupees Two crore four lakh and twenty five thousand only) with the state share of Rs.10.75 lakh (Rupees Ten lakh and seventy five thousand only) under RIDF XVII.
- 6. The expenditure towards the work sanctioned in para 5 above shall be debited to the following new head of account, opened under Demand No.40.01:-
 - "4701 Capital Outlay on Major and Medium Irrigation 03 Medium Irrigation-Commercial 345 Medium irrigation schemes Schemes in the Eleventh Five Year Plan—II State Plan JZ Rehabilitation and Improvements to 16 anicut in Kallar river of Vaniar Minor Basin in Pappireddypatty taluk of Dharmapuri District with Loan assistance from NABARD under RIDF XVII 16 Major works."(DPC 4701-03–345-JZ-1609).
- 7. The Engineer-in-Chief, Water Resources Department is the Estimating, Reconciling and Controlling authority for the above new sub-head of account.
- 8. The Pay and Accounts Officer /Treasury Officers concerned are requested to open the above new Sub-Head of Account in their accounts.
- 9. The expenditure relates to the work sanctioned in para 5 above constitutes an item of "New Service" for which the approval of the Legislature will be obtained in due course. Pending approval of the legislature, initially this expenditure will be met by drawal of advance from the Contingency Fund, orders regarding which will be issued by the Government in Finance (BG-I) Department separately. The Engineer-in-Chief, Water Resources Department, Chennai-5 is directed to send a proposal to Government in Finance (BG-I) Department in the prescribed format, along with a copy of this order for sanction of advance from the Contingency Fund. Further, he is also requested to

send necessary draft explanatory notes for the inclusion of the above expenditure in the Supplementary Estimates for the year 2011-2012 without fail at the appropriate stage.

10. This order issues with the concurrence of the Finance Department vide its U.O. No.211/DS(B)/PWII/2011 dated: 12.12.2011 and Additional Sanction Ledger No. 1065 (One thousand and sixty five).
