## ORDER:

In the G.O. first read above, orders were issued directing that the Regional Chief Engineers and Functional Chief Engineers of Public Works Department be vested with the powers, whenever necessary for fixing / shifting of headquarters of Sub divisions / Sections, which fall under their jurisdiction for a period of two years from 05.02.1999 and extended from time to time and in the G.O. third read above, the delegation of powers were lastly extended upto 31.03.2010.

2. The Engineer-in-Chief, Water Resources Department and Chief Engineer(General), now, stated that there is necessity for shifting the Headquarters of Sub divisions/ Sections of Water Resources Department, whenever the works are to be executed depending upon the nearness, desired to the workspot. Further, it reduces unnecessary travel both by the Public and the officers and the expenditure towards travelling allowance, fuel consumption of vehicles, etc. The Engineer-in-Chief, has, therefore, requested the orders of the Government to extend the delegation

of powers to the Chief Engineers of Water Resources Department in respect of shifting the headquarters of Sub divisions / Sections of Water Resources Department, which fall under their jurisdiction for a further period of three years from 01.04.2010 to 31.03.2013.

- 3. The Government, after careful consideration of the proposal of the Engineer-in-Chief, Water Resources Department, direct that the powers delegated to the Functional Chief Engineers and Regional Chief Engineers of Water Resources Department for fixing / shifting the headquarters of Sub divisions / Sections, which fall under their jurisdiction, shall be extended for a further period of three years from 01.04.2010 to 31.03.2013.
- 4. This order issues with the concurrence of Finance Department vide its U.O.No.280/DSVP/PW II/2010, dated: 09.06.2010.
