ORDER:

The Chief Engineer, Water Resources Department, Plan Formulation in his letter read above has stated that Santhanavarthini River is a tributary of Kodaganar river originates from Northern slopes of Sirumalai hills near Ayyapatti village and finally joins with Kodaganar river. There are number of anicuts across Santhanavarthini river. These anicuts play a vital role in the system. Muthankulam anicut is one of the anicuts constructed across Santhnavarthini river. During the recent floods, the entire anicut was collapsed and the supply channel could not receive water from the river. In order to get better irrigation and to stabilize the existing ayacut, the collapsed anicut needs to be restored. He has also stated that it is proposed to reconstruct the anicut and to protect the flood banks from erosion by providing retaining wall in both sides of upstream and downstream sides of anicut with the necessary bank connections. By implementing this scheme, assured irrigation supply will be provided to an extent of 107.24 acres through 4 Numbers of tanks. The cost of scheme for the schedule of rates 2010-2011 works out to Rs.35.00 lakhs. The work will be executed by the Chief Engineer, Water Resources Department, Coimbatore Region. Hence no additional staff will be required for executing the scheme.

2. The above scheme is approved by the Standing Finance Committee under Part II Schemes for the year 2010-2011. Accordingly, the Government accord administrative sanction for the reconstruction of

Muthankulam anicut across Santhanavarthini river at M.M. Kovilur village of Dindigul Taluk and District at a total cost of Rs. 35.00 lakhs (Rupees Thirty five lakhs only). Petty Supervision charges and unforeseen items should not exceed 2.5% of total cost of works.

3. The expenditure sanctioned in paragraph 2 above, shall be debited to the following head of account:-

"4701 – Capital Outlay on Major and Medium Irrigation – 03. Medium Irrigation – Commercial – 422. Rehabilitation, Renovation and Modernization Irrigation Structures – Schemes in the Eleventh Five Year Plan – II. State Plan – JB. Reconstruction of dilapidated Muthankulam anicut across Santhanavarthini river at M.M. Kovilur village of Dindigul District – 16. Major Works" (DP code 4701 – 03 – 422 – JB 1603).

- 4. The Chief Engineer, Water Resources Department, Coimbatore Region is requested to take up the work immediately and complete it within the cost and time limit. He is also requested to send the progress of the work to the Government, every month, periodically.
