## ORDER:

The Government in the G.O. read above, have sanctioned a sum of Rs.450.00 lakhs under Part-II Scheme for the year 2006-2007 with the loan assistance to be obtained from NABARD for providing dividing wall below the existing Aqueduct and necessary energy Dissipation arrangement and construction of anaicut across Koundanya Nadhi near Chittathur in Gudiyatham Taluk, Vellore District. In the reference second read above, the Chief Engineer, Public Works Department, Chennai Region has stated that this scheme is very essential and this has been announced under Part-II Scheme 2006-2007 and that has therefore, requested the Government to sanction this scheme under State Funds, since release of loan assistance from NABARD would take some more time.

2) The Government have examined the proposal of the Chief Engineer, Public Works Department, Chennai Region in detail and administrative sanction is accorded for a sum of Rs.450.00 lakhs (Rupees four hundred and fifty lakhs only) under State Fund for providing dividing wall below the existing aqueduct and necessary energy dissipation arrangements and construction of anicut across Koundanya Nadhi near Chittathur in Gudiyatham Taluk in Vellore District subject to receipt of NABARD loan assistance and the expenditure made from State fund shall reimbursed and adjusted suitably.

- 3) The expenditure sanctioned in para 2 above shall be debitable under the following head of account:
  - "4701-Capital Outlay on Major and Medium Irrigation 03. Medium Irrigation Commercial 345. Medium Irrigation Schemes in the XI<sup>th</sup> Five Year Plan-II State Plan-JD. Providing dividing wall and construction of anicut across Koundanya Nadhi near Chitthathur Village in Gudiyatham Taluk in Vellore District with loan assistance from NABARD under RIDF Scheme-16. Major Works" (D.P.Code 4701-03-345 JD 1603)
- 4) The Chief Engineer, Water Resources Organisation, Public Works Department, Chennai Region is requested to incur the required expenditure for the above work under State Funds under the provision available in BE 2007-2008 under head of account indicated at para 3 above the balance amount will be provided after utilization of the above provision in BE 2007-2008.
