ORDER:

The Engineer in Chief, Water Resources Organisation and Chief Engineer (General), Public Works Department, in his letter first read above, has submitted an estimate for Rs.16.59 lakhs for the formation of a pond near Krishnakuppam of Mailarwada Village in Pallipet Taluk of Tiruvallur District, with loan assistance from National Bank for Agriculture and Rural Development (NABARD) under Rural Infrastructure Development Fund-XII and requested administrative sanction of the Government.

2. In the letter second read above, the National Bank for Agriculture and Rural Development, has conveyed its acceptance for providing Loan Assistance under Rural Infrastructure Development Fund - XII for the above scheme at the following funding pattern:-

The NABARD has also reported that the ineligible cost of Rs.0.38 lakhs has to be borne by the State Government in addition to its contribution of Rs.0.81 lakhs. Hence, the State Government's contribution comes to Rs.1.19 lakhs (Rs.38,000/- towards ineligible cost + Rs.81,000/- towards State Government share = Rs.1,19,000/-).

3. The Government after careful consideration, accord Administrative Sanction for taking up the work of formation of a Pond near Krishnakuppam of Mailarwada Village in Pallipet Taluk, Tiruvallur District at a total Project Cost of Rs.16.59 lakhs (Rupees Sixteen lakhs and fifty nine thousand only), including Rs.1.19 lakhs (Rupees One lakh and nineteen thousand only) as the share of the State Government (Rs.38,000/- as ineligible cost + Rs.81,000/- = Rs.1,19,000/-) and with the Loan Assistance of Rs.15.40 lakhs (Rupees Fifteen lakhs and forty thousands only) from NABARD under Rural Infrastructure Development Fund - XII.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

"4702 - 00 Capital Outlay on Minor Irrigation - 101. Surface Water - Schemes in the Eleventh Five Year Plan - II. State Plan - JK. State Minor Irrigation Project with Loan Assistance from NABARD under Rural Infrastructure Development Fund - XII New Schemes - 16. Major Works (D.P.Code 4702 - 00 - 101 - JK-1607)."

5. Necessary funds will be provided in the Final Modified Appropriation 2007-2008. Pending provision of funds, the Engineer in Chief, Water Resources Organisation and Chief Engineer (General), Public Works Department is permitted to incur the expenditure sanctioned for the above scheme. He is also requested to include the

above item of expenditure, while sending the proposals for Final Modified Appropriation 2007-2008 to the Government in Finance Department, without fail.

6. This order issues with the concurrence of Finance Department vide its U.O. No. 23/DS(AR)/2008-1, Dated 13.02.2008 and Additional Sanction Ledger No. 1824 (One thousand eight hundred and twenty four).
