In the Government Order first read above, orders have been issued according administrative sanction for an amount of Rs.2457 Crore for the implementation of Tamil Nadu Irrigated Agriculture Modernisation and Water Bodies Restoration and Management (IAMWARM) Project in 61 Sub Basins in Tamil Nadu for a period of six years from 2007 to 2013.

2. In his letter second read above, the Engineer-in-Chief, Water Resources Department, Chennai has requested the Government to accord administrative sanction for an amount of Rs.66,000/- towards the purchase of computer consumables for the office of the Chief Engineer, Plan Formulation, Water Resources Organization, Chepauk, Chennai-5 for the year 2012-2013. The Empowered Committee has restricted the expenditure to Rs.66,000/- as against the original proposal for sanction of Rs.1,90,000/- for purchase of computer consumables for the office of the Chief Engineer, Plan Formulation, Water Resources Organization, the pauk, Chennai-5 for the year 2012-2013.

3. The Government after careful consideration have decided to accept the proposal of the Engineer-in-Chief, Water Resources Department, Chennai duly recommended by the Empowered Committee and accord administrative sanction for Rs.66000/- (Rupees Sixty Six Thousand only) towards the purchase of computer consumables for the office of the Chief Engineer (Plan Formulation), Chennai-5 for the year 2012-2013 as detailed in the annexure to this order.

4. The expenditure sanctioned in para 3 above shall be debitable under the following head of account:-

5. Necessary funds will be provided in FMA 2012-2013. Pending Provision of funds in FMA 2012-13, the Engineer in Chief, Water Resources Department is authorized to incur the above expenditure sanctioned in para 3 above. He is also requested to include the above expenditure while sending budget proposals for FMA 2012-13 to Finance (PW-II) Department at an appropriate time without fail.

This file relates to the proposal of the Project Director, IAMWARM requesting to sanction a sum of Rs.36,23,610/- (Rupees Thirty Six Lakhs Twenty Three Thousand Six Hundred and Ten Only) for entrusting the Internal Audit of the TN IAMWARM Project (Phase III & IV Covering Selected 25 Sub-basins) to M/s. Padmanabhan Ramani and Ramanujam, Chartered Accountants, Chennai evaluated as L1 in the tender for a period of one year from 15.11.2012 covering the audit related to two years starting from April 2011 to March 2013.

2. In G.O.(Ms) No.298, Public Works Department, dated 7.10.2008, the Internal Audit for a period of three years covering expenditure of four years for the eight Line Departments of phase I and II at a cost of **Rs.99.89 Lakhs** was carried out by an Audit Firm "M/s. Padmanabhan Ramani & Ramanujam, Chartered Accountants.

3. The Project Director, IAMWARM has stated that the Internal Audit works of Phase I & II of TN IAMWARM Project has been completed as per agreement. The World Bank, in their aide memoire dated 18.03.2011, have stated that the Internal Audit of Phase III & IV may be carried out in six Line Departments (excluding Fisheries and Animal Husbandry departments) for selected 25 sub basins of TN IAMWARM Project.

The proposal related to two years starting from April 2011 to March 2013 was sent to the World Bank with the TOR (Terms of Reference). The World Bank has issued their **No Objection** vide their e-mail dated 18.11.2011.

In the G.O.(Ms) No.73, Public Works Department, dated 29.3.2012 orders have been issued for the estimation of **Rs. 62.00 Lakhs** for appointment of Internal Auditor for a period of one year for audit related to two years starting from April 2011 to March 2013 for conducting Audit on the works of selected 25 sub basins of Phase III & IV of TN IAMWARM Project. The Tender Evaluation committee recommended M/s. Padmanabhan Ramani & Ramanujam, Chennai evaluate (L1), as Highest Score based on the combined evaluation of both Finance and Technical proposal, since the firm has quoted Rs.36.23 Lakhs (Including service tax @ 12.36%).

The Empowered Committee has approved the proposal of Internal Audit of TN IAMWARM Project (Phase III & IV Covering Selected 25 Sub-basins) by a Chartered Accountant Firm namely, M/s. Padmanabhan Ramani and Ramanujam, Chartered Accountants, Chennai, which quoted Rs.36,23,610/- for entrusting the Internal Audit to the firm evaluated as L1 in the tender for a period of one year from 15.11.2012 covering the audit related to two years starting from April 2011 to March 2013.

4. Hence, the Project Director, IAMWARM has requested to sanction a sum of Rs.36,23,610/- (Rupees Thirty Six Lakhs Twenty Three Thousand Six Hundred and Ten Only) for entrusting the Internal Audit of the TN IAMWARM Project (Phase III & IV Covering Selected 25 Sub-basins) to M/s. Padmanabhan Ramani and Ramanujam, Chartered Accountants, Chennai, evaluated as L1 in the tender for a period of one year from 15.11.2012 covering the audit related to two years starting from April 2011 to March 2013.
