This file relates to the proposal of the Engineer in Chief, Water Resources Department, Chennai requesting to accord Administrative Sanction for an amount of Rs.1.00 lakhs towards the proposal of purchase of stationeries required to maintain the computers available in the Designs Circle, Chepauk, Chennai-5 for the year 2012-2013.

2. The Engineer in Chief, Water Resources Department, Chennai has submitted the proposal as follows:-

In G.O.(Ms) No.119, Public Works Department, dated 10.5.2007, IAMWARM Project was sanctioned with an outlay of Rs. 2547 Crore for implementation in 61 Sub Basins in Tamil Nadu for a period of six years from 2007 to 2013 and the component for WRD is Rs.1785.62 Crore.

The Designs Circle is a Central Design Office under Water Resources Organisation of Public Works Department evolving scientific, practical and economical designs for the components of various Irrigation Projects in Tamil Nadu based on the input furnished by the field engineers. The designs are based on the BIS, latest techniques practiced in India and abroad.

The designs are being evolved using computers by developing suitable programme and the drawings are being prepared using AutoCAD software. The designs for the works under IAMWARM project have to be evolved by this Circle. The designs for the IAMWARM works referred by the four regions of WRO have to be completed in time to complete the project within the stipulated target period. During review of the IAMWARM works at different occasions the World Bank members insisted the field engineers to check the designs with this Central Design Office.

In addition to the above routine works, the following works under the IAMWARM Project is also taken up in the Designs Circle.

- Consulting services for 'Construction Quality Management and Technical Supervision'.

- Procurement of software, journals, scientific equipments and laboratory equipments.

Further it is necessary to create permanent records of all the technical works and documentation of the above works under the IAMWARM project. All the above works are to be carried out with the aid of computers and its peripherals. The Designs Circle and Designs Division is presently equipped with computers, printers, fax machines, photocopiers etc which have been purchased under IAMWARM project.

In G.O.(Ms) No.208, Public Works Department, dated 19.7.2010 orders have been issued sanctioning a sum of Rs.1.50 lakhs for the purchase of Stationeries required to maintain the Computers available in the O/o the Special Chief Engineer, WRD, PWD, Designs Circle and O/o the Executive Engineer, Designs Division, Chennai-5 for the year 2010-2011 and the present proposal is for the Purchase of stationeries required to maintain the computers available in the Designs Circle under IAMWARM Project. In this estimate, provision has been made for the purchase of consumables as per prevailing local market rates for the purchase of materials such as toners for printers, fax machines, photocopiers, CD's A4 and A3 Xerox paper etc.

The proposal for the purchase of stationeries required to maintain the computers available in the Designs Circle under IAMWARM Project has been circulated among the members of Empowered Committee and it has been cleared on 18.01.13.

The Engineer in Chief, Water Resources Department, Chennai has also enclosed the General Abstract which may be perused on p.3 cf.

3. Hence, he has requested to accord Administrative Sanction for the proposal of purchase of stationeries required to maintain the computers available in the Designs Circle, Chepauk, Chennai-5 for the year 2012-13 for an amount of Rs.1.00 lakhs.

4.
