In G.O.(Ms) No. 206, Public Works (WR1) Department, dated 17.06.2008, administrative sanction was accorded for a sum of Rs. 42.4371 crore for implementation of Information Technology and Information Management System, Procurement of I.T. Components, along with the provision for an Information Technology consultant to execute the work through M/s Electronics Corporation of Tamil Nadu (ELCOT) on payment of appropriate charges to it and a sum of Rs.18.00 lakhs has been allocated for a period of 3 years (i.e. Rs. 50,000/-p.m) for the post of IT Consultant

- 2. The Managing Director, Electronics Corporation of Tamil Nadu (ELCOT) has proposed to select and engage a suitable technically qualified person from Man power tender finalized by ELCOT and obtained rates for various positions through man power consultancy tender including technical experts for assistance of Government departments. After analyzing the eligibility criteria designed for the position, Technical Expert (5+ years experience) is found acceptable and rate per man month works out to Rs.51,450/-. Since, the remuneration falls within the amount mentioned in the Government Order, ELCOT has proposed to deploy a suitable candidate for the post of Technical Expert. He has requested concurrence for deploying a suitable candidate for the position of Technical Expert through M/s Peri Software Solutions Ltd in the office of the Engineer-in-Chief, Water Resources Department to carryout the implementation of EIMS work with immediate effect for a period of two years.
- 3. The Engineer in Chief has stated that there is no information technology expert persons are present in Water Resources Department and it is right time to appoint a IT consultant in his Office for effective co-ordinating with the EIMS consultant and also to

guide Water Resources Department for effective implementation of IT activities. The IT consultant post has been approved by the Empowered Committee in its 5th meeting and orders were issued in the Government Order first read above. He has also stated that the proposal submitted by M/s. ELCOT for hiring Technical Expert for a period of two years is found acceptable at the rate of Rs.51,450/ per month is well within the overall Administrative Sanctioned amount.
