ORDER:

In the G.O. first read above, the Government have accorded Administrative Sanction for the construction of an Anicut across the surplus course of Kannankottai Hisa Rajaneri Tank below the infall of Thervoy Periya Eri surplus in Thervoy Kandigai Village in Gummidipoondi Taluk of Tiruvallur District at an estimated cost of Rs. 100.82 lakhs.

2. The Engineer in Chief, Water Resources Organisation, and Chief Engineer (General), in his letter second read above has sent the revised estimate for a sum Rs. 164.00 lakhs for the construction of an Anicut across Kannankottai Hisa Rajaneri in Gummidipoondi Taluk in Tiruvallur District with NABARD Loan Assistance under RIDF XI, at the schedule of rates for the year 2007 – 2008 and requested to accord revised Administrative Sanction at a cost of Rs. 164.00 lakhs.

- 3. The Government after careful examination accord Revised Administrative Sanction for Rs. 164.00 lakhs (Rupees One Hundred and Sixty Four lakhs only) (Rs. 95.78 lakhs (Rupees Ninety Five Lakhs and Seventy Eighty thousands only) being the loan assistance from NABARD + Rs. 68.22 lakhs(Rupees Sixty Eight Lakhs and Twenty Two thousands only) being the share of the State Government) for the construction of an Anicut across Kannankottai Hisa Rajaneri in Gummidipoondi Taluk in Tiruvallur District with NABARD Loan Assistance under RIDF XI.
- 4. The amount sanctioned in para 3 above shall be debited to the following head of account:-
 - 4701. Capital Outlay on Major and Medium Irrigation 03. Medium Irrigation - Commercial-345. Medium Irrigation Schemes - Schemes in the Eleventh Five Year Plan - II. State Plan JB. Renovation of existing irrigation channels, tanks and strengthening of dams with loan assistance from NABARD under RIDF-XI Schemes-16.Major Works (DPC-4701-03-345-JB-1607)
- 5. The expenditure sanctioned in para 3 above constitute an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course.
- 6. The amount sanctioned above will be directly included in final supplementary Estimates for 2007-2008.
