ORDER:

The Engineer-in-Chief, Water Resources Organisation, and Chief Engineer (General), Public Works Department, in his letter first read above, has reported that NABARD cleared three schemes in Erode District with loan assistance under Rural Infrastructure Development Fund – XII for an amount of Rs.63.91 lakhs with State Government's share of Rs.3.20 lakhs. The estimate was revised to Rs.78.15 lakhs at the Schedule of Rates for the year 2006-2007. The escalation cost at 7% has also been made and the total Project Cost for the above scheme arrives to at Rs.83.61 lakhs. The Chief Engineer, Plan Formulation, in his letter second read above, has furnished 3 revised estimates for the above three schemes by adopting the schedule of Rates for the year 2007 – 08 and requested administrative sanction for the above schemes.

2) The Government after careful consideration, accept the proposal and accord administrative sanction for the following three schemes in Erode District at the total cost of Rs.83.61 Lakhs (Rupees eighty three lakhs and sixty one thousands only) as detailed below:-

3) The expenditure sanctioned in para 2 above shall be debited under the following head of account :-

“4702 00 - Capital out lay on Minor Irrigation 101 – surface water - Schemes in the Eleventh Five Year Plan II State Plan JK State Minor Irrigation Project with Loan Assistance from NABARD under RIDF - New Schemes – 16 Major works. (D.P.Code 4702 00 101 JK 1607)

4) The expenditure sanctioned in paragraph 2 above, constitutes an item of “New Instrument of Service” and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure shall initially be met by drawal of an advance from the Contingency Fund orders regarding which will be issued from the Finance(BG.I) Department, separately. The Engineer-in-Chief, Water Resources Organisation and Chief Engineer (General), Public Works Department, is requested to send an application in the prescribed format for the sanction of an advance from the Contingency fund for the required amount, to the Government in Finance (BG. I) Department, together with a copy of this order. He is also requested

to send necessary explanatory notes to Finance (Public Works.II) Department for inclusion of the above expenditure in the final Supplementary Estimates for the year 2007-2008 at the appropriate time without fail.

5) This order issues with concurrence of Finance Department vide its U.O.No.734/PWII/2008-1, dated 10.1.2008 and Additional Sanction Ledger No.1658 (one thousand six hundred and fifty eight)
