### ORDER:

The Chief Engineer (Buildings) in his letter read above has stated that in view of the World Classical Tamil Conference 2010 which is to be held between 23-27, June 2010, Inspection Bungalow and Circuit House in Coimbatore have become important places as they have to accommodate V.V.I.P.s and delegates. In view of the above, certain essential electrical improvement works are to be carried out in the Inspection Bungalow and Circuit House in Coimbatore. The Chief Engineer (Buildings), Public Works Department has therefore prepared estimates for carrying out the following works in Inspection Bungalow, Circuit House at Coimbatore.

2.	Supply, Erection, Commissioning, testing and handing over of 75 KVA Diesel Generator with panel board arrangements with shed in Kumanan Illam at Inspection Bungalow & Circuit House at Coimbatore.	8,60,000/-
3.	Improvements to Electrical Installation Fittings distribution arrangements and A.C. facilities T.V. arrangements in the Annexe building of Inspection Bungalow & Circuit House at Coimbatore.	8,15,000/-

4. Special Repair to Electrical Installation, fans, fittings in PWD suites (1A, 2A, 8A suites) and additional Annex building (3 Suits) in the Inspection Bungalow & Circuit house at Coimbatore.	6,45,000/-
5. Improvement to Electrical Installation, Fittings, distribution, street light arrangements and provision of T.V. facilities in the Main suites / V.V.I.P. buildings (M1, M2, M3 & M4) of Inspection Bungalow & Circuit House at Coimbatore.	9,50,000/-
6. Supply, Erection, Commissioning, testing and handing over of 75 K.V.A. Diesel Generator set with panel arrangements with shed in Main Suite Complex at Inspection Bungalow & Circuit House at Coimbatore.	8,60,000/-
7. Provision of 13 person capacity passenger lift (Ground Floor + First Floor) with civil structure provision in the Main Suite Inspection Bungalow & Circuit House at Coimbatore	26,00,000/-
Total	Rs.76,80,000/-

The Chief Engineer(Buildings) has also stated that no fund provision has been made for meeting the expenditure relating to the above works in Budget Estimate/Revised Estimate 2009-2010. Hence he has requested the Government to accord necessary approval for the above estimates and also accord administrative sanction for Rs.76.80 lakhs for carrying out electrical improvement works in Inspection Bungalow and Circuit House at Coimbatore in view of the World Classical Tamil Conference 2010 to be held from 23-27 June 2010 at Coimbatore. He has also requested for necessary fund provision to meet the above expenditure.

2. The Government after careful consideration has decided to accept the proposal of Chief Engineer (Buildings), Public Works Department and accord administrative sanction for Rs.76,80,000/- (Rupees Seventy six lakhs and eighty thousand only) for carrying out the essential electrical improvement works indicated at para 1 above in the Inspection Bungalow and Circuit House at Coimbatore.

3. The expenditure sanctioned in para 2 above shall be debited to the following head of account:-

“ 4059 Capital Outlay on Public Works – 80 General – 800 other Expenditure-II State Plan- JA. Works in connection with the World Classical Tamil Conference – 16 Major Works. (DPC 4059-80-800-JA 1609)”

4. The Chief Engineer(Buildings), Public Works Department is directed to take early action for commencement of the above electrical works and to ensure that the work is completed within the stipulated time and within the estimate amount.

5. The original estimates sent to Government in the letter read above are returned to Chief Engineer(Buildings), Public Works Department, Chennai-5
