ORDER:

During the Budget Speech 2022-2023, the Hon'ble Minister for Finance and Human Resources Management among others has made the following Announcement:-

2. The Hon'ble Minister (Public Works) has made the following announcement on the floor of the Assembly on 12.04.2022 while moving the Public Works Department Demand No. 39:-

"17 பாரம்பரிய கட்டடங்கள் ரூ.100 கோடி மதிப்பீட்டில் பாதுகாப்பு மற்றும் மறுசீரமைத்து புணரமைக்கப்படும்."

3. Based on the announcement made by the Hon'ble Minister (Public Works), the Engineer-in-Chief and Chief Engineer (General), Public Works Department, Chennai in his letter read above has sent the Detailed Estimate for Rs. 103.74 for the work of Conservation, Renovation and Restoration of 17 Heritage Buildings functioning as Government Office Buildings, Court under Judicial Department and as other important

Buildings in Chennai, Madurai, Ramanathapuram, Pudukkottai, Thanajvur, Coimbatore, Tiruvannamalai, Kanniyakumari, Theni, Tiruchirappalli and Erode Districts.

- 4. The Engineer in Chief and Chief Engineer, Public Works Department has stated that the Detailed Estimates for the 17 Heritage Building works have been prepared based on the Schedule of Rates for the year 2022-2023 and with 18% GST based on the Government of India Notification dated 18.07.2022, for a total sum of Rs.103.74 crore and requested necessary administrative and financial sanction of the Government.
- 5. After careful examination of the proposal of the Engineer-in-Chief and Chief Engineer (General), Public Works Department, Chennai, the Government hereby accord administrative and financial sanction for a sum of Rs.103,74,00,000/- (Rupees One hundred three crore and seventy four lakh only) for the works of Conservation, Renovation and Restoration of 17 Heritage Buildings functioning as Government Office Buildings, Court under Judicial Department and as other important Buildings in Chennai, Madurai, Ramanathapuram, Pudukkottai, Thanajvur, Coimbatore, Tiruvannamalai, Kanniyakumari, Theni, Tiruchirappalli and Erode Districts, as detailed below:-

- 7. The expenditure sanctioned in para 6 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Engineer-in-Chief and Chief Engineer (General), Public Works Department is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G.I) Department. The Engineer-in-Chief and Chief Engineer (General), Public Works Department is also directed to send a draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2022-2023 to Finance (BG.I/PW-I) Department without fail.
- 8. The Engineer-in-Chief and Chief Engineer (General), Public Works Department is authorized to incur the expenditure sanctioned in para 5 above.
