ORDER:

The Hon'ble Minister (Public Works) while moving the Public Works Department Demand No.39 in the Tamil Nadu Legislative Assembly for the year 2022-2023 has made the following announcement: -

- " சென்னை மண்டலம், வேலூரில் கூடுதல் சுற்றுலா மாளிகை ரூ.6.80 கோடி மதிப்பீட்டில் கட்டப்படும்"
- 2. Based on the above announcement made by the Hon'ble Minister (Public Works), the Engineer-in-Chief, Chief Engineer (General) and Chief Engineer, Chennai Region, Public Works Department, Chepauk, Chennai in the letters read above has sent the Detailed Estimate for Rs.7.65 crore for the Construction of Additional Circuit House Building at Vellore prepared based on the Schedule of Rates for the year 2022-2023 with 18% G.S.T based on the Government of India Notification dated 18.07.2022 and requested necessary administrative and financial sanction of the Government.
- 3. After careful examination of the proposal of the Engineer-in-Chief and Chief Engineer (General), Public Works Department, Chepauk, Chennai, the Government hereby accord Administrative Sanction for a sum of Rs.7,63,53,757/- (Rupees Seven crore sixty three lakh, fifty three thousand, seven hundred and fifty seven only) for the work of "Construction of Additional Circuit House Building in the Campus of the Circuit House at Vellore in Vellore District" in order to implement the announcement made by the Hon'ble Minister (Public Works). Further, Financial Sanction is accorded for a sum of Rs.3,00,00,000/- (Rupees three crore only) for the financial year 2022-2023. The balance amount will be released in the subsequent financial years.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

"4059 - Capital Outlay on Public Works-01-Office Buildings - 051-Construction — State's Expenditure — JJ - Public Works — 416 — Major Works -01. Major Works." (IFHRMS DPC: 4059-01-051-JJ-41601)

- 5. The expenditure sanctioned in para 3 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Engineer-in-Chief and Chief Engineer (General), Public Works Department is directed to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G.I) Department. The Engineer-in-Chief and Chief Engineer (General), Public Works Department is also directed to send a draft explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2022-2023 to Finance (BG.I/PW.I) Department without fail.
- 6. The Engineer-in-Chief and Chief Engineer (General), Public Works Department, Chepauk, Chennai is authorized to incur the expenditure sanctioned in para 3 above.
- 7. This order issues with the concurrence of Finance Department vide its U.O. No.43800/Finance (PW-I) / 2022, dated 22.09.2022 and Additional Sanction Ledger No.1296 (one thousound two hundred and ninety six) (IFHRMS ASL No. 2022091296).
