ORDER:

In the Letter first read above, the Commissioner of Rural Development and Panchayat Raj has sent a proposal for formation of 2 Rural Road works in Namakkal District stating that under Pradhan Mantri Gram Sadak Yojana (PMGSY), in the case of hilly areas, new roads are constructed in 2 stages as under,

- The first stage consists of formation cutting, slope stabilization, protective works and drainage works
- The second stage includes base layers and bituminous surfacing.

2. He has further stated that this issue was discussed with NABARD on 26.04.2023 and NABARD has accepted to permit stage construction under RIDF for the above road. Accordingly, the District Collector, Namakkal has submitted revised proposal for the formation (first stage) of the following two roads of length 31.07 Km at a total cost of Rs.139.654 crore vide the District Collector, Namakkal District, Letter No.565/2007/A6, dated 26.04.2023 and the same is proposed to be met from NABARD-RIDF (2023-24).

i) Formation of road from Vadugam to Melur via Keelur Km 0/0 – 21/170

- Formation includes Cutting, Filling, Hard rock cutting without blasting and construction of embankment using carted earth.
- In total, 72 Pipe culverts, three 5m span RCC slab culverts and two 6 m span RCC slab culverts have been proposed.
- PCC retaining wall for a length of 10,926 m and RCC retaining wall for a length of 8416 m have been proposed.
- 63 Hairpin bends
- LWF 1%, GST 18%, Escalation cost 5% and contingencies

ii Formation of road from Pudhupatti to Kedamalai road Km 0/0 – 9/900

- Formation includes Cutting, Filling, Hard rock cutting without blasting and construction of embankment using carted earth.
- In total, 51 Pipe culverts, four 3m span RCC slab culvert, one 5m span RCC slab culvert and one 2x5m span RCC slab culvert has been proposed.
- PCC retaining wall for a length of 6,040 m and RCC retaining wall for a length of 665 m were proposed.
- 37 Hairpin bends.
- LWF 1%, GST 18%, Escalation cost 5% and contingencies

3. In the Letter 2nd read above, the Deputy General Manager, NABARD has stated that the Internal Sanctioning Committee in its 120th meeting held on 19th July 2023, among other things has sanctioned an amount of Rs.13965.40 Lakh as RIDF loan to Rural Development and Panchayat Raj Department as follows:-

4. The Commissioner of Rural Development and Panchayat Raj has therefore requested the Government to sanction and release a sum of Rs.13965.40 Lakh for formation of 2 Rural Roads as indicated in para 2 above under NABARD-RIDF XXIX for the year 2023-24.

5. The Government have carefully examined the above proposal of the Commissioner of Rural Development and Panchayat Raj in detail and decided to accept the same and accord administrative sanction and financial sanction for a sum of Rs.139,65,40,000/- (Rupees One Hundred and Thirty Nine Crore Sixty Five Lakh and Forty Thousand only) for formation of 2 Rural Roads in Namakkal District with loan assistance from the NABARD under RIDF--XXIX for the year 2023-2024 as annexed to this order and order accordingly.
